

AN ACT

To further amend Public Law No. 19-10, as amended by Public Laws Nos. 19-26, 19-42, 19-51, 19-56, 19-72, 19-78, 19-96, 19-132, 19-163, 20-03, 20-25, 20-58, 20-76, 20-116, 21-29, 21-64, 21-196, 22-10, 22-133, 23-84, 23-163 and 24-12, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2 Section 1. Section 4 of Public Law No. 19-10, as amended by
3 Public Laws Nos. 19-26, 19-42, 19-72 and 19-78, is hereby further
4 amended to read as follows:

5 "Section 4. Of the sum of \$2,800,000 appropriated by
6 this act, \$800,000 is apportioned for public projects
7 and social programs in the state of Pohnpei.

22	Section 2. Section 6 of Public Law No. 19-10, as amended	
23	by Public Laws Nos. 19-26, 19-42, 19-72, 19-96, 20-25, 20-116,	
24	21-29, 21-64, 21-196, 22-10, 22-133, 23-84, 23-163 and 24-12, is	
25	hereby further amended to read as follows:	

1 "Section 6. Allotment and management of funds and lapse
2 date. All funds appropriated by this act shall be
3 allotted, managed, administered and accounted for in
4 accordance with applicable laws, including, but not
5 limited to, the Financial Management Act of 1979. The
6 allottee shall be responsible for ensuring that these
7 funds, or so much thereof as may be necessary, are used
8 solely for the purpose specified in this act, and that
9 no obligations are incurred in excess of the sum
10 appropriated. The allottee of the funds appropriated
11 under section 2 of this act shall be the Governor of Yap
12 State; PROVIDED THAT, the allottee of funds appropriated
13 under subsection 2(h) of this act shall be the President
14 of COM-FSM. The allottee of funds appropriated under
15 sections 3 and 4 of this act shall be the President of
16 the Federated States of Micronesia or his designee;
17 PROVIDED THAT, the allottee of funds appropriated under
18 subsections 3(a), (b), (c), (d), (e), (f), (g), (h),
19 (i), (j) and (k) of this act shall be the Mayor of Lelu
20 Town Government; the allottee of funds appropriated
21 under section 3(l) of this act shall be the Mayor of
22 Malem Municipal Government or his designee; the allottee
23 of funds appropriated under subsection 3(y) of this act
24 shall be the Mayor of Tafunsak Municipal Government or
25 his designee; the allottee of funds appropriated under

1 3(ab) of this act shall be the Governor of Kosrae or his
2 designee; the allottee of funds appropriated under
3 subsections 4(1)(a), 4(1)(b), 4(2)(g), 4(2)(h) and
4 4(3)(o) of this act shall be the Secretary of the
5 Department of Transportation, Communications and
6 Infrastructure; the allottee of funds appropriated under
7 subsections 4(2)(i), 4(3)(a), 4(3)(b) and 4(3)(d) of
8 this act shall be the Pohnpei Transportation Authority;
9 and the allottee of funds appropriated under subsections
10 4(3)(f) and 4(3)(h) of this act shall be the Pohnpei
11 Utility Corporation. The allottee of funds appropriated
12 under subsections 5(1), 5(3) and 5(6) of this act shall
13 be the Governor of Chuuk State or his designee. The
14 allottee of funds appropriated under subsection 5(2) of
15 this act shall be the Mortlock Islands Development
16 Authority. The allottee of funds appropriated under
17 subsection 5(4) of this act shall be the Southern
18 Namoneas Development Authority. The allottee of funds
19 appropriated under subsection 5(5) of this act shall be
20 the Faichuk Development Authority. The authority of the
21 allottee to obligate funds appropriated by this act
22 shall lapse on September 30, 2026."
