



AN ACT

To further amend Public Law No. 18-70, as amended by Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, 19-41, 19-52, 19-73, 19-82, 19-101, 19-114, 19-139, 20-07, 20-16, 20-36, 20-52, 20-81, 20-84, 21-15, 21-113, 21-123, 21-175, 21-192, 21-208, 21-222, 22-75, 22-130, 23-82, 23-142 and 24-14, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 18-70, as amended by
2 Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, 19-52, 20-36,
3 20-52, 20-84, 21-175, 21-192 and 24-14, is hereby further amended to
4 read as follows:

5 "Section 4. Of the sum of \$5,100,000 appropriated by
6 this act, \$1,450,000 is apportioned for public projects
7 and social programs in the state of Pohnpei.

11 Section 2. Section 6 of Public Law No. 18-70, as amended by
 12 Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, 19-101, 20-07,
 13 20-52, 20-84, 21-15, 21-123, 22-75, 22-130, 23-82, 23-142 and 24-14,
 14 is hereby further amended to read as follows:


15 "Section 6. Allotment and management of funds and lapse
 16 date. All funds appropriated by this act shall be
 17 allotted, managed, administered and accounted for in
 18 accordance with applicable laws, including, but not
 19 limited to, the Financial Management Act of 1979. The
 20 allottee shall be responsible for ensuring that these
 21 funds, or so much thereof as may be necessary, are used
 22 solely for the purpose specified in this act, and that
 23 no obligations are incurred in excess of the sum
 24 appropriated. The allottee of the funds appropriated
 25 under section 2 of this act shall be the Governor of Yap

1 State EXCEPT THAT the funds appropriated under
2 subsection 2(i) shall be the President of COM-FSM. The
3 allottee of funds appropriated under sections 3 and 4 of
4 this act shall be the President of the Federated States
5 of Micronesia or his designee; EXCEPT THAT the funds
6 appropriated under subsections a, b, c, d, e, f, g, h,
7 i, j, k, l, m, n, o, s, t, u, v, w, x, ag, ah, aj and ap
8 of section 3 this act shall be the Mayor of Lelu Town
9 Government or his designee; the allottee of funds
10 appropriated under subsection 3(q) of this act shall be
11 the Mayor of Malem Municipal Government or his designee;
12 the allottee of funds appropriated under subsections
13 3(y), 3(aa) and 3(ao) of this act shall be the Governor
14 of Kosrae or his designee; the allottee of funds
15 appropriated under sections 3(aq) and 3(ar) of this act
16 shall be the Mayor of Malem Municipal Government or his
17 designee; the allottee of funds appropriated under
18 sections 4(3)(a), 4(3)(n), 4(3)(t) and 4(3)(ae) of this
19 act shall be the Secretary of the Department of
20 Transportation, Communications and Infrastructure or his
21 designee; the funds appropriated under subsections a, b,
22 c, d, e, f and g of section 4(1), subsections 4(3)(b),
23 (c), (d), (f), (p), (r), (ac) and (ad) of this act shall
24 the Pohnpei Transportation Authority; the allottee of
25 funds appropriated under section 4(3)(u) of this act

shall be the Pohnpei Utility Corporation. The allottee of funds appropriated under subsection 4(3)(aa) of this act shall be the Meninkeder Lapalap of Madolenihmw; the allottee of funds appropriated under subsection 4(4)(f) shall be the Mayor of Mwokilloa Municipal Government or his designee the allottee of funds appropriated under subsection 4(4)(l) shall be the Mayor of Pingelap Municipal Government or his designee. The allottee of funds appropriated under subsections 5(1) and 5(6), of this act shall be the Governor of Chuuk State or his designee. The allottee of funds appropriated under subsection 5(2) of this act shall be the Mortlock Islands Development Authority. The allottee of funds appropriated under subsection 5(3) of this act shall be the Mayor of Weno Municipal Government or his designee. The allottee of funds appropriated under subsection 5(4) of this act shall be the Southern Namoneas Development Authority. The allottee of funds appropriated under subsection 5(5) of this act shall be the Faichuk Development Authority. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2026."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
