

AN ACT

To further amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45, 18-59, 18-86, 19-11, 19-106, 19-110, 20-108, 21-16, 21-122, 22-124 and 23-77, by amending section 6 thereof, for the purpose of changing the allottee of certain funds previously appropriated therein, to fund public projects and social programs for Kosrae state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 6 of Public Law No. 16-49, as amended by  
2 Public Laws Nos. 17-10, 17-45, 17-85, 18-28, 18-86, 19-11, 19-106,  
3 19-110, 20-108, 21-16, 21-122, 22-124 and 23-77, is further hereby  
4 amended to read as follows:

5       "Section 6. Allotment and management of funds and lapse  
6 date. All funds appropriated by this act shall be  
7 allotted, managed, administered and accounted for in  
8 accordance with applicable law, including, but not  
9 limited to, the Financial Management Act of 1979. The  
10 allottee shall be responsible for ensuring that these  
11 funds, or so much thereof as may be necessary, are used  
12 solely for the purpose specified in this act, and that no  
13 obligations are incurred in excess of the sum  
14 appropriated. The allottee of funds appropriated under  
15 sections 2 and 4 of this act shall be the President of  
16 the Federated States of Micronesia or his designee;  
17 PROVIDED THAT, the allottee of funds appropriated under

1 subsection 2(1)(h) of this act shall be the Mayor of Lelu  
2 Town Government or his designee; the allottee of funds  
3 appropriated under section 4(1)(b) shall be the Pohnpei  
4 Transportation Authority and the allottee of the funds  
5 appropriated under section 4(1)(j) shall be the Mayor of  
6 Kolonia Town Government. The allottee of funds  
7 appropriated under section 3 of this act shall be the  
8 Governor of Yap State. The allottee of funds  
9 appropriated under subsections 5(1), 5(6) and 5(7) of  
10 this act shall be the Governor of Chuuk State or his  
11 designee. The allottee of funds appropriated under  
12 subsection 5(2) of this act shall be the Mortlock Islands  
13 Development Authority (MIDA). The allottee of funds  
14 appropriated under subsection 5(3) of this act shall be  
15 the Mayor of Weno Municipal Government or his designee.  
16 The allottee of funds appropriated under subsection 5(4)  
17 of this act shall be the Southern Namoneas Development  
18 Authority. The allottee of funds appropriated under  
19 subsection 5(5) of this act shall be the Faichuk  
20 Development Authority. The funds appropriated by this  
21 act shall lapse on September 30, 2026."

1           Section 2. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
