
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 20-68, as amended by Public Laws Nos. 20-78, 20-89, 20-176, 21-95, 21-138, 21-197, 22-116, 23-88, 23-156 and 24-10, by amending section 6 thereof, to change allottee of funds therein, for the purpose of funding public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1.   Section 5 of Public Law No. 20-68, as  
2 amended by Public Laws Nos. 20-89, 21-95, 21-138, 22-116,  
3 23-88 and 24-10, is hereby further amended to read as  
4 follows:

5           "Section 5.   Allotment and management of funds and  
6           lapse date. All funds appropriated by this act shall  
7           be allotted, managed, administered and accounted for  
8           in accordance with applicable laws, including, but  
9           not limited to, the Financial Management Act of 1979.  
10          The allottee shall be responsible for ensuring that  
11          these funds, or so much thereof as may be necessary,  
12          are used solely for the purpose specified in this  
13          act, and that no obligations are incurred in excess  
14          of the sum appropriated. The allottee of the funds  
15          appropriated under sections 2 and 3 of this act shall  
16          be the President of the Federated States of  
17          Micronesia or his designee; PROVIDED THAT the  
18          allottee of funds appropriated under subsections

1           2(a), 2(b) and 2(h) of this act shall be the Mayor of  
2           Lelu Town Government or his designee; the allottee of  
3           funds appropriated under subsections 2(c) to 2(g) of  
4           this act shall be the Mayor of Tafunsak Municipal  
5           Government or his designee; the allottee of funds  
6           appropriated under sections 2(i) and 2(j) of this act  
7           shall be the Mayor of Malem Municipal Government or  
8           his designee; the allottee of funds appropriation  
9           under subsection 3(1)(i) of this act shall be the  
10          Chief Magistrate of Sokehs Municipal Government or  
11          his designee; the allottee of funds appropriated  
12          under subsection 3(2)(a) of this act shall be the  
13          President of the COM-FSM Institute or his designee;  
14          the allottee of funds appropriated under subsection  
15          3(2)(b) of this act shall be the Pohnpei  
16          Transportation Authority; the allottee of funds  
17          appropriated under subsections 3(2)(c) to 3(2)(g) of  
18          this act shall be the Secretary of the Department of  
19          Transportation, Communications and Infrastructure or  
20          his designee; the allottee of funds appropriated under  
21          subsections 3(4)(a) shall be the President of the  
22          COM-FSM Institute or his designee; the allottee of  
23          funds appropriated under subsection 3(4)(b) of this  
24          act shall be the Mayor of Pingelap Municipal  
25          Government or his designee; the allottee of funds

---

1           appropriated under subsection 3(4)(c) of this act  
2           shall be the Mayor of Mwokilloa Municipal Government  
3           or his designee. The allottee of funds appropriated  
4           under subsections 4(1) and 4(6) of this act shall be  
5           the Governor of Chuuk State or his designee. The  
6           allottee of funds appropriated under subsection 4(2)  
7           of this act shall be the Mortlock Islands Development  
8           Authority. The allottee of funds appropriated under  
9           subsection 4(3) of this act shall be the Mayor of  
10          Weno Municipal Government or his designee. The  
11          allottee of funds appropriated under subsection 4(4)  
12          of this act shall be the Southern Namoneas  
13          Development Authority. The allottee of funds  
14          appropriated under subsection 4(5) of this act shall  
15          be the Faichuk Development Authority. The authority  
16          of the allottee to obligate funds appropriated by  
17          this act shall lapse on September 30, 2026."

1       Section 2. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
