
Dear Speaker Moses:

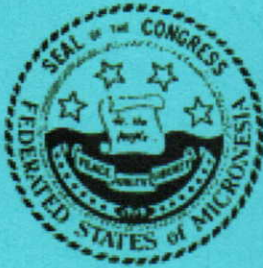

AN ACT

To amend Public Law No. 21-228, as amended by Public Laws Nos. 21-248, 22-12, 22-22, 22-36, 22-74, 22-90, 23-18 and 23-25, by amending section 6 thereof, to extend the lapse date of funds appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 6 of Public Law No. 21-228, as amended by  
2 Public Laws Nos. 21-248 and 23-25, is hereby further amended to  
3 read as follows:

4           "Section 6. Allotment and management of funds and lapse  
5 date. All funds appropriated by this act shall be  
6 allotted, managed, administered and accounted for in  
7 accordance with applicable laws, including, but not  
8 limited to, the Financial Management Act of 1979. The  
9 allottee shall be responsible for ensuring that these  
10 funds, or so much thereof as may be necessary, are used  
11 solely for the purpose specified in this act, and that no  
12 obligations are incurred in excess of the sum  
13 appropriated. The allottee of the funds appropriated  
14 under section 2 of this act shall be the Governor of Yap  
15 State or his designee. The allottee of funds appropriated  
16 under sections 3 and 4 of this act shall be the President  
17 of the Federated States of Micronesia or his designee,  
18 PROVIDED THAT the allottee of funds appropriated under

1 subsection 3(1) of this act shall be the Governor of  
2 Kosrae State or his designee; the allottee of funds  
3 appropriated under subsection 3(2) of this act shall be  
4 the Mayor of Lelu Town Government or his designee; the  
5 allottee of funds appropriated under subsections 4(1) and  
6 4(2) of this act shall be the Secretary of the Department  
7 of Transportation, Communications and Infrastructure or  
8 his designee; EXCEPT THAT, the allottee of funds  
9 appropriated under subsection 4(1)(a) of this act shall be  
10 the Secretary of the Department of Health and Social or a  
11 designee; the allottee of funds appropriated under  
12 subsection 4(1)(b) of this act shall be the Secretary of  
13 the Department of Education or his designee; the allottee  
14 of funds appropriated under subsection 4(2)(f) of this act  
15 shall be the Pohnpei Transportation Authority and the  
16 allottee of funds appropriated under subsection 4(2)(m) of  
17 this act shall be the President of the COM-FSM; the  
18 allottee of funds appropriated under subsection (4)(3) of  
19 this act shall be the Pohnpei Transportation Authority;  
20 EXCEPT THAT the allottee of funds appropriated under  
21 subsections 4(3)(i) and 4(3)(j) of this act shall be the  
22 Luhken Menlap of Kittu or his designee; and the allottee  
23 of funds appropriated under subsection 4(3)(k) of this act  
24 shall be the President of the Federated States of  
25 Micronesia of his designee. The allottee of funds

appropriated under subsections 4(4)(d) and 4(4)(e) of this act shall be the Pohnpei Transportation Authority; the allottee of funds appropriated under subsection 4(4)(k) of this act shall be the Mayor of Pingelap Municipal Government or his designee. The allottee of funds appropriated under subsection 4(4)(l) of this act shall be the Mayor of Mwokilloa Municipal Government or his designee. The allottee of the funds appropriated under subsections 5(1) and 5(6) of this act shall be the Governor of Chuuk State or his designee; the allottee of the funds appropriated under subsection 5(2) of this act shall be the Mortlocks Island Development Authority (MIDA); the allottee of funds under subsection 5(3) of this act shall be the Mayor of Weno or his designee; the allottee of the funds appropriated under subsection 5(4) of this act shall be the Southern Namoneas Development Authority; the allottee of the funds appropriated under subsection 5(5) of this act shall be the Faichuk Development Authority. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2027."

1       Section 2. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
