CONGRESSIONAL BILL NO. 24-58

AN ACT

To further amend Public Law No. 23-122, as amended by Public Laws Nos. 23-138 and 24-06, by amending section 5 thereof, for the purpose of changing the use of funds previously appropriated therein, to fund public projects and social programs for the people of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 23-122, as amended by


