

AN ACT

To appropriate the sum of \$100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2025, for the purpose of funding the funeral expenses of the late President and Senator Joseph J. Urusemal, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Purpose. The sum of \$100,000, or so much thereof
2 as may be necessary, is hereby appropriated from the General Fund
3 of the Federated States of Micronesia for the fiscal year ending
4 September 30, 2025, for the purpose of funding the funeral
5 expenses of the late President and Senator Joseph J. Urusemal:

6 (1) Funeral expenses of the late President and
7 Senator Joseph J. Urusemal.....\$ 100,000

8 Section 2. Allotment and management of funds and lapse
9 date. All funds appropriated by this act shall be allotted,
10 managed, administered, and accounted for in accordance with
11 applicable laws, including, but not limited to, the Financial
12 Management Act of 1979, as amended. The allottee shall be
13 responsible for ensuring that these funds, or so much thereof as
14 may be necessary, are used solely for the purpose specified in
15 this act and that no obligations are incurred in excess of the
16 sum appropriated. The allottee of the funds appropriated under
17 Section 1 of this act shall be the President of the Federated
18 States of Micronesia. The authority of the allottee to obligate
19 funds appropriated by this act shall lapse on December 31, 2025.

1 Section 3. This act shall be come law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


