
Dear Speaker Moses:

AN ACT

To amend section 103 of title 3 of the Code of the Federated States of Micronesia (Annotated), and repeal section 104 in its entirety, to correct names of offices, clarify reporting lines and create an Office of Information Technology (IT) for the Congress of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. section 103 of title 3, of the Code of the  
2 Federated States of Micronesia (Annotated), is hereby amended to  
3 read as follows:

4           "Section 103. Immediate offices.

5           "There shall be the following offices which shall be  
6 under the direct supervision of the Presiding Officer:

- 7           (1) Office of the Chief Clerk;  
8           (2) Public Information Office;  
9           (3) Office of the Administrator;  
10          (4) Office of Budget;  
11          (5) Office of the Legislative Counsel; and  
12          (6) Office of Information Technology (IT)."

13       Section 2. Section 104 of title 3 of the Code of the  
14 Federated States of Micronesia (Annotated), is hereby repealed  
15 in its entirety.

1       Section 3. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.


