

AN ACT

To amend Public Law No. 24-40, by amending sections 2, 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein to fund public projects and social programs for the people of Yap and Pohnpei states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 2 of Public Law No. 24-40 is hereby  
2 amended to read as follows:

3               "Section 2. Of the \$2,100,000 appropriated under  
4 this act, \$300,000 shall be apportioned to fund  
5 public projects and social programs for the people of  
6 Yap.

19 Section 3. Section 6 of Public Law No. 24-40 is hereby  
20 amended to read as follows:

21 "Section 6. Allotment and management of funds and  
22 lapse date. All funds appropriated by this act shall  
23 be allotted, managed, administered and accounted for  
24 in accordance with applicable laws, including, but not  
25 limited to, the Financial Management Act of 1979. The


1 allottee shall be responsible for ensuring that these  
2 funds, or so much thereof as may be necessary, are  
3 used solely for the purpose specified in this act, and  
4 that no obligations are incurred in excess of the sum  
5 appropriated. The allottee of the funds appropriated  
6 under section 2 of this act shall be the Governor of  
7 Yap or his designee; PROVIDED THAT, the President of  
8 the College of Micronesia – FSM shall be allottee of  
9 funds appropriated under section 2(c). The allottee  
10 of the funds appropriated under subsection 3(2) of  
11 this act shall be the Mayor of Lelu Town Government or  
12 his designee. The allottee of the funds appropriated  
13 under section 4 of this act shall be the President of  
14 the Federated States of Micronesia or his designee.  
15 The allottee of funds appropriated under section 3(1)  
16 of this act shall be the Mayor of Malem Municipal  
17 Government or his designee. The allottee of funds  
18 appropriated under sections 4(2), 4(3)(d), 4(3)(e) and  
19 4(4)(d) of this act shall be the Secretary of the  
20 Department of Transportation, Communications and  
21 Infrastructure or his designee. The allottee of funds  
22 appropriated under subsections 4(3)(a), 4(3)(b) and  
23 4(3)(c) shall be the Pohnpei Transportation Authority  
24 (PTA). The allottee of the funds appropriated under  
25 subsections 5(1) and 5(6) of this act shall be the



1 Governor of Chuuk State or his designee; the allottee  
2 of the funds appropriated under subsection 5(2) of  
3 this act shall be the Mortlocks Island Development  
4 Authority (MIDA); the allottee of the funds  
5 appropriated under subsection 5(3) of this act shall  
6 be the Mayor of Weno Municipal Government or his  
7 designee; the allottee of the funds appropriated under  
8 subsection 5(4) of this act shall be the Southern  
9 Namoneas Development Authority; the allottee of the  
10 funds appropriated under subsection 5(5) of this act  
11 shall be the Faichuk Development Authority. The  
12 authority of the allottee to obligate funds  
13 appropriated by this act shall lapse on September 30,  
14 2028".

15 Section 4. This act shall become law upon approval by the  
16 President of the Federated States of Micronesia or upon its  
17 becoming law without such approval.
