

AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05, 20-15, 20-33, 20-48, 20-63, 20-71, 20-156, 20-175, 21-22, 21-52, 21-146, 21-156, 21-195, 21-213, 21-244, 22-25, 22-62, 22-111, 23-38, 23-55, 23-62, 23-131, 23-150, 24-23 and 24-44, by amending sections 3, 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund priority infrastructure projects and other programs for Kosrae and Pohnpei States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 19-124, as amended
2 by Public Law No. 19-140, 20-05 and 24-44, is hereby further
3 amended to read as follows:

17 23-55, 23-62, 23-131, 24-23 and 24-44, is hereby further amended

18 to read as follows:

19 "Section 6. Allotment and management of funds and

20 lapse date. All funds appropriated by this act shall

21 be allotted, managed, administered and accounted for in

22 accordance with applicable laws, including, but not

23 limited to, the Financial Management Act of 1979. The

24 allottee shall be responsible for ensuring that these

25 funds, or so much thereof as may be necessary, are used


solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of the State of Yap or his designee. The allottee of the funds appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsections 3(1)(a) and 3(1)(b) of this act shall be the Governor of Kosrae State or his designee the allottee of funds appropriated under subsection 3(1)(c) of this act shall be the Mayor of Malem Municipal Government or his designee, the allottee of funds appropriated under subsections 4(1)(c), 4(1)(d), 4(1)(e), 4(1)(g), 4(1)(h), 4(1)(i), 4(1)(j), 4(1)(k), 4(1)(l), 4(1)(m), 4(1)(n), 4(1)(o), 4(2)(f), 4(3)(d) 4(3)(k), 4(3)(q), 4(3)(af), 4(3)(as), 4(4)(b), 4(4)(d) and 4(4)(f), shall be the Pohnpei Transportation Authority (PTA); the allottee of funds appropriated under subsections 4(1)(a), 4(1)(b), 4(1)(f), 4(1)(p), 4(1)(q), 4(1)(r), 4(1)(s), 4(1)(t), 4(1)(u), 4(1)(v), 4(2)(c), 4(2)(d), 4(2)(e), 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j), 4(3)(s), 4(3)(x), 4(3)(o), 4(3)(ar) 4(3)(p), 4(3)(q), 4(3)(at) shall be the Secretary of the Department of

1 Transportation, Communications and Infrastructure or
2 his designee; the allottee of funds appropriated under
3 subsections 4(3)(f), 4(3)(i), 4(3)(w), 4(3)(aw) and
4 4(3)(aa) of this act shall be the Luhk en Moanlap of
5 Kitti, the allottee of funds appropriated under
6 subsection 4(3)(ad) of this act shall be the Chief
7 Justice of Madolenihmw or his designee, the allottee of
8 funds appropriated under subsection 4(3)(ae) of this
9 act shall be the Chief Justice of Kitti or his
10 designee; the allottee of funds appropriated under
11 subsection 4(3)(an) of this act shall be the Secretary
12 of the Department of Health and Social Affairs or his
13 designee; the allottee of the funds appropriated under
14 subsections 4(3)(ak) and 4(3)(ao) of this act shall be
15 the Vice President of the Federated States of
16 Micronesia or his designee; the allottee of funds
17 appropriated under subsections 4(3)(al), 4(3)(ap) ,
18 4(3)(au) and 4(3)(av) of this act shall be the
19 Meninkeder Lapalap of Madolenihmw Municipal Government
20 or his designee. The allottee of funds appropriated
21 under sections 5(2) and 5(7) of this act shall be the
22 Governor of Chuuk State or his designee; the allottee
23 of funds appropriated under subsection 5(1)(3) of this
24 act shall be the Mortlock Islands Development Authority
25 (MIDA); the allottee of funds appropriated under

subsections 5(1)(o), 5(1)(p) 5(1)(1) and 5(1)(4) of this act shall be the Mayor of Weno Municipal Government or his designee; EXCEPT THAT the allottee of funds appropriated under subsection 5(1)(m) of this act shall be the FSM Telecommunication Corporation; the allottee of funds appropriated under subsection 5(1)(5) of this act shall be the Southern Namoneas Development Authority (SNDA); the allottee of funds appropriated under subsection 5(1)(6) of this act shall be the Faichuk Development Authority. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2026."

Section 4. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
