
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 19-10, as amended by Public Laws Nos. 19-26, 19-42, 19-51, 19-56, 19-72, 19-78, 19-96, 19-132, 19-163, 20-03, 20-25, 20-58, 20-76, 20-116, 21-29, 21-64, 21-196, 22-10, 22-133, 23-84, 23-163 and 24-12, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2 Section 1. Section 4 of Public Law No. 19-10, as amended by
3 Public Laws Nos. 19-26, 19-42, 19-72 and 19-78, is hereby further
4 amended to read as follows:

5 "Section 4. Of the sum of \$2,800,000 appropriated by
6 this act, \$800,000 is apportioned for public projects
7 and social programs in the state of Pohnpei.

21 Section 2. Section 6 of Public Law No. 19-10, as amended
 22 by Public Laws Nos. 19-26, 19-42, 19-72, 19-96, 20-25, 20-116,
 23 21-29, 21-64, 21-196, 22-10, 22-133, 23-84, 23-163 and 24-12, is
 24 hereby further amended to read as follows:

25 "Section 6. Allotment and management of funds and lapse

date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap State; PROVIDED THAT, the allottee of funds appropriated under subsection 2(h) of this act shall be the President of COM-FSM. The allottee of funds appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsections 3(a), (b), (c), (d), (e), (f), (g), (h), (i), (j) and (k) of this act shall be the Mayor of Lelu Town Government; the allottee of funds appropriated under section 3(l) of this act shall be the Mayor of Malem Municipal Government or his designee; the allottee of funds appropriated under subsection 3(y) of this act shall be the Mayor of Tafunsak Municipal Government or his designee; the allottee of funds appropriated under 3(ab) of this act shall be the Governor of Kosrae or his

1 designee; the allottee of funds appropriated under
2 subsections 4(1)(a), 4(1)(b), 4(2)(g), 4(2)(h) and
3 4(3)(o) of this act shall be the Secretary of the
4 Department of Transportation, Communications and
5 Infrastructure; the allottee of funds appropriated under
6 subsections 4(2)(i), 4(3)(a), 4(3)(b) and 4(3)(d) of
7 this act shall be the Pohnpei Transportation Authority;
8 and the allottee of funds appropriated under subsections
9 4(3)(f) and 4(3)(h) of this act shall be the Pohnpei
10 Utility Corporation. The allottee of funds appropriated
11 under subsections 5(1), 5(3) and 5(6) of this act shall
12 be the Governor of Chuuk State or his designee. The
13 allottee of funds appropriated under subsection 5(2) of
14 this act shall be the Mortlock Islands Development
15 Authority. The allottee of funds appropriated under
16 subsection 5(4) of this act shall be the Southern
17 Namoneas Development Authority. The allottee of funds
18 appropriated under subsection 5(5) of this act shall be
19 the Faichuk Development Authority. The authority of the
20 allottee to obligate funds appropriated by this act
21 shall lapse on September 30, 2026."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its becoming
3 law without such approval.


