

AN ACT

To further amend Public Law No. 22-180, as amended by Public Laws Nos. 22-187, 22-188, 23-03, 23-09, 23-11, 23-36, 23-59, 23-118, 23-124, 23-139, 23-145 and 24-16, by amending sections 4 and 6 thereof, for the purpose of changing the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2 Section 1. Section 4 of Public Law No. 22-180, as
3 amended by Public Laws Nos. 22-188, 22-09, 23-11, 23-36,
4 23-118, 23-145 and 24-16, is hereby further amended to read

13 Section 2. Section 6 of Public Law No. 22-180, as
14 amended by Public Laws Nos. 22-188, 23-11, 23-36, 23-118,
15 23-124, 23-139 and 24-16, is hereby further amended to read
16 as follows:

17 "Section 6. Allotment and management of funds and
18 lapse date. All funds appropriated by this act shall
19 be allotted, managed, administered and accounted for
20 in accordance with applicable laws, including, but not
21 limited to, the Financial Management Act of 1979. The
22 allottee shall be responsible for ensuring that these
23 funds, or so much thereof as may be necessary, are
24 used solely for the purpose specified in this act, and
25 that no obligations are incurred in excess of the sum

1 appropriated. The allottee of the funds appropriated
2 under section 2 of this act shall be the Governor of
3 Yap State or his designee. The allottee of funds
4 appropriated under sections 3 and 4 of this act shall
5 be the President of the Federated States of Micronesia
6 or his designee; EXCEPT THAT, the allottee of funds
7 appropriated under section 3(1) of this act shall be
8 the Governor of Kosrae State or his designee; the
9 allottee of funds appropriated under section 3(2) of
10 this act shall be the Mayor of Lelu Town Government or
11 his designee; PROVIDED THAT, the allottee of funds
12 appropriated under subsection 3(2)(x) of this act
13 shall be the Mayor of Utwe Municipal Government or his
14 designee; the allottee of funds appropriated under
15 subsection 3(2)(y) of this act shall be the Mayor of
16 Malem or his designee; the allottee of funds
17 appropriated under subsections 4(1)(b), 4(1)(k),
18 4(1)(l), 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d), 4(2)(e),
19 4(2)(g), 4(2)(h), 4(2)(p), 4(2)(s), 4(2)(t), 4(2)(u),
20 4(2)(v), 4(3)(q) and 4(2)(aa), 4(3)(a) 4(2)(ab) of
21 this act shall be the Secretary of the Department of
22 Transportation, Communications and Infrastructure or
23 his designee; the allottee of funds appropriated under
24 subsections 4(1)(a), 4(1)(j), 4(2)(f), 4(2)(j),
25 4(2)(k), 4(2)(l), 4(2)(m), 4(2)(r), 4(2)(x), 4(3)(m),

1 4(3)(n), 4(3)(s), 4(2)(n), and 4(3)(t) of this act
2 shall be the Pohnpei Transportation Authority (PTA);
3 the allottee of funds appropriated under subsection
4 4(2)(i) of this act shall be the Secretary of the
5 Department of Education or her designee; the allottee
6 of funds appropriated under subsection 4(2)(o) of this
7 act shall be the Pohnpei Port Authority (PPA); the
8 allottee of funds appropriated under subsections
9 4(2)(w), 4(2)(q) and 4(2)(z) of this act shall be the
10 Mayor of Sapwuahfik Municipal Government or his
11 designee, the allottee of funds appropriated under
12 subsections 4(2)(ac) and 4(2)(ad) of this act shall be
13 the Sokehs Municipal Government; the allottee of funds
14 appropriated under section 4(3)(e) of this act shall
15 be the Secretary of the Department of Health and
16 Social Affairs; the allottee of the funds appropriated
17 under subsections 5(1) and 5(6) of this act shall be
18 the Governor of Chuuk State or his designee; the
19 allottee of the funds appropriated under subsection
20 5(2) of this act shall be the Mortlocks Island
21 Development Authority (MIDA); the allottee of the
22 funds appropriated under subsection 5(3) of this act
23 shall be the Mayor of Weno Municipal Government or his
24 designee; the allottee of the funds appropriated under
25 subsection 5(4) of this act shall be the Southern

7 Section 3. This act shall become law upon approval by the
8 President of the Federated States of Micronesia or upon its
9 becoming law without such approval.
