
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 18-99, as amended by Public Laws Nos. 18-106, 18-113, 18-121, 19-05, 19-34, 19-57, 19-74, 19-107, 20-18, 20-24, 20-80, 20-112, 21-28, 21-106, 21-131, 21-177, 22-129 and 23-81, by amending sections 4 and 6 thereof, to change the allottee and use of funds previously appropriated therein, to fund public projects and social programs for the people of the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 18-99, as amended by
2 Public Law No. 18-113, 18-121, 19-05, 19-34 and 20-18, is hereby
3 amended to read as follows:

4 "Section 4. Of the \$2,800,000 appropriated in this act,
5 \$800,000 is appropriated for public projects and social
6 programs for the people of the State of Pohnpei.

15 Section 2. Section 6 of Public Law No. 18-99, as amended
 16 by Public Laws Nos. 18-113, 18-121, 19-05, 19-34, 19-107, 20-18,
 17 20-24, 20-112, 21-28, 21-131, 22-129 and 23-91, is hereby
 18 further amended to read as follows:

19 "Section 6. Allotment and management of funds and lapse
 20 date. All funds appropriated by this act shall be
 21 allotted, managed, administered and accounted for in
 22 accordance with applicable laws, including, but not
 23 limited to, the Financial Management Act of 1979. The
 24 allottee shall be responsible for ensuring that these
 25 funds, or so much thereof as may be necessary, are used

1 section 4(3)(k) shall be the Secretary of the Department
2 of Health and Social Affairs or his designee. The
3 allottee of funds appropriated under sections 5(1) and
4 5(6) of this act shall be the Governor of Chuuk State or
5 his designee. The allottee of funds appropriated under
6 subsection 5(2) of this act shall be the Mortlock
7 Islands Development Authority. The allottee of funds
8 appropriated under subsection 5(3) of this act shall be
9 the Mayor of Weno Municipal Government or his designee.
10 The allottee of funds appropriated under subsection 5(4)
11 of this act shall be the Southern Namoneas Development
12 Authority. The allottee of funds appropriated under
13 subsection 5(5) of this act shall be the Faichuk
14 Development Authority. The authority of the allottee to
15 obligate funds appropriated by this act shall lapse on
16 September 30, 2026."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
