CONGRESSIONAL RESOLUTION NO. 24-110

A RESOLUTION

To confirm the nomination of Mr. Etop Malone to serve as a member of the Board of Directors of MiCare, representing the state of Chuuk.

1 WHEREAS, in accordance Section 409 of Title 52 of the Code
2 of the Federated States of Micronesia (Annotated), as amended,
3 the Board of Directors of MiCare is composed of seven (7)
4 members, including one representative from each State of the
5 Federated States of Micronesia, who shall be recommended by the
6 Governor of the relevant State; and

7 WHEREAS, Section 407(2) of Title 52 of the Code of the
8 Federated States of Micronesia (Annotated), as amended,
9 empowers the President of the Federated States of Micronesia to
10 appoint one member from each State with the advice and consent
11 of Congress; and

12 WHEREAS, the President has nominated Mr. Etop Malone to
13 represent the state of Chuuk on the MiCare Board of Directors,
14 and the nomination is subject to the advice and consent of
15 Congress as aforesaid; and

16 WHEREAS, Mr. Etop Malone is qualified to serve as a MiCare
17 Board member based on his educational background and
18 professional experience; now, therefore,

1 BE IT RESOLVED by the Twenty-Fourth Congress of the
2 Federated States of Micronesia, Third Regular Session, 2026,
3 that Congress hereby confirms the nomination of Mr. Etop Malone
4 to serve as member of the Federated States of Micronesia MiCare
5 Board of Directors, representing Chuuk State; and

6 BE IT FURTHER RESOLVED that certified copies of this
7 resolution be transmitted to the President of the Federated
8 States of Micronesia, the Secretary of the Department of
9 Justice, and Mr. Etop Malone.




