A RESOLUTION

To confirm the nomination of Mr. Sebastian L. Anefal to serve as a member of the Board of Directors of MiCare, representing the state of Yap.

1        WHEREAS, in accordance Section 409 of Title 52 of the Code  
2 of the Federated States of Micronesia (Annotated), as amended,  
3 the Board of Directors of MiCare is composed of seven (7)  
4 members, including one representative from each State of the  
5 Federated States of Micronesia, who shall be recommended by the  
6 Governor of the relevant State; and

7        WHEREAS, Section 407(2) of Title 52 of the Code of the  
8 Federated States of Micronesia (Annotated), as amended,  
9 empowers the President of the Federated States of Micronesia to  
10 appoint one member from each State with the advice and consent  
11 of Congress; and

12       WHEREAS, the President has nominated Mr. Sebastian L.  
13 Anefal to represent the state of Yap on the MiCare Board of  
14 Directors, and the nomination is subject to the advice and  
15 consent of Congress as aforesaid; and

16       WHEREAS, Mr. Sebastian L. Anefal is qualified to serve as  
17 a MiCare Board member based on his educational background and  
18 professional experience; now, therefore,


