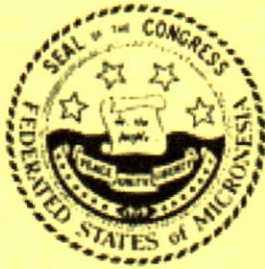

A RESOLUTION

Approving and accepting a grant in the amount of \$199,256 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment, to fund the Substance Abuse Prevention, Treatment and Recovery Services Block Grant, including all the terms and conditions of the assistance.

1        WHEREAS, the United States Department of Health and Human  
2        Services, Substance Abuse and Mental Health Services  
3        Administration, Center for Substance Abuse Treatment, issued a  
4        Grant Award on August 22, 2025, in the amount \$199,256 to the  
5        Government of the Federated States of Micronesia; and

6        WHEREAS, the purpose of the grant is to provide financial  
7        support to the FSM Department of Health and Social Affairs for the  
8        planning, implementation, and evaluation of evidence-based  
9        activities that (i) prevent substance abuse, (ii) treat substance  
10       use disorders, and (iii) support long-term recovery services among  
11       youth and other targeted populations throughout the FSM; and

12       WHEREAS, section 210(2) of title 55 of the Code of the  
13       Federated States of Micronesia (Annotated), as amended, provides  
14       that for foreign financial assistance to be valid it must be  
15       approved by Congress by resolution; now, therefore,

16       BE IT RESOLVED by the Twenty-Fourth Congress of the Federated  
17       States of Micronesia, Second Special Session, 2025, that Congress  
18       hereby approves and accepts the \$199,256 grant from the United

1 States Department of Health and Human Services, Substance Abuse  
2 and Mental Health Services Administration, Center for Substance  
3 Abuse Treatment, including all the terms and conditions thereof;

5 BE IT FURTHER RESOLVED that certified copies of this  
6 resolution be transmitted to the President of the Federated States  
7 of Micronesia, the Secretary of the Department of Health and  
8 Social Affairs, the Secretary of the Department of Justice, and  
9 the Secretary of the Department of Finance and Administration.


