

TO APPROVE AND ACCEPT A GRANT IN THE AMOUNT OF THE \$196,241 FROM THE UNITED STATES DEPARTMENT OF HEALTH AND HUMAN SERVICES, CENTERS FOR DISEASE CONTROL AND PREVENTION, PROVIDING FUNDING FOR THE FSM EPIDEMIOLOGY AND LABORATORY CAPACITY FOR PREVENTION AND CONTROL OF EMERGING INFECTIOUS DISEASE (ELC), INCLUDING ALL THE TERMS AND CONDITIONS OF THE ASSISTANCE.

CONGRESSIONAL RESOLUTION NO. 24-77

A RESOLUTION

To approve and accept a grant in the amount of the \$196,241 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, providing funding for the FSM Epidemiology and Laboratory Capacity for Prevention and Control of Emerging Infectious Disease (ELC), including all the terms and conditions of the assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services, Centers for Disease Central and Prevention, issued a
3 Grant Award on September 11, 2025, to the Government of the
4 Federated States of Micronesia to providing funding in the
5 amount of \$196,241 for the purpose of providing support for the
6 FSM Epidemiology and Laboratory Capacity for Prevention and
7 Control of Emerging Infectious Disease (ELC); and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended, requires
10 that for foreign financial assistance to be valid it must be
11 approved by Congress by resolution; now, therefore,

12 BE IT RESOLVED by the Twenty-Fourth Congress of the
13 Federated States of Micronesia, Second Special Session, 2025,
14 that Congress hereby approves and accepts the \$196,241 grant
15 from the United States Department of Health and Human Services,
16 Centers for Disease Control and Prevention, including all the
17 terms and conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Secretary of the Department of
4 Justice, and the Secretary of the Department of Health and
5 Social Affairs, and the Secretary of the Department of Finance
6 and Administration.


