Approving and accepting a grant in the amount of \$250,000 from the United States Department of the Interior, to fund the FSM Single Audit, including all the terms and conditions of the assistance.

1 WHEREAS, on August 27, 2025, the Department of the Interior  
2 (DOI) of the United States Government, issued a grant to the  
3 Federated States of Micronesia in the amount \$250,000 to fund  
4 the FSM Single Audit; and

5 WHEREAS, section 210(2) of title 55 of the Code of the  
6 Federated States of Micronesia provides that for foreign  
7 financial assistance to be valid it must be approved by Congress  
8 by resolution; now, therefore,

9 BE IT RESOLVED by the Twenty-Fourth Congress of the  
10 Federated States of Micronesia, Second Special Session, 2025,  
11 that Congress hereby approves and accepts the \$250,000 grant  
12 from the United State Department of the Interior to fund the  
13 FSM Single Audit, including all the terms and conditions


