CONGRESSIONAL RESOLUTION NO. 24-81

A RESOLUTION

To approve and accept a grant in the amount of the \$114,354 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to support the FSM Preventive Health and Health Services Block Grant 2025, including all the terms and conditions of the assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services, Centers for Disease Central and Prevention, issued a
3 Grant Award on September 08, 2025, to the Government of the
4 Federated States of Micronesia providing support to the FSM
5 Preventive Health and Health Services Block Grant 2025; and
6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, requires
8 that for foreign financial assistance to be valid it must be
9 approved by Congress resolution, now, therefore,

10 BE IT RESOLVED by the Twenty-Fourth Congress of the
11 Federated States of Micronesia, Second Special Session, 2025,
12 that Congress hereby approves and accepts the \$114,354 grant
13 from the United States Department of Health and Human Services,
14 Centers for Disease Control and Prevention, including all the
15 terms and conditions thereof; and


