TO APPROVE AND ACCEPT A GRANT IN THE AMOUNT OF \$341,164 FROM THE UNITED STATES DEPARTMENT OF HEALTH AND HUMAN SERVICES, CENTERS FOR DISEASE CONTROL AND PREVENTION, TO SUPPORT THE FSM BEHAVIORAL RISK FACTORS SURVEILLANCE SYSTEM (BRFSS) PROGRAM, INCLUDING ALL THE TERMS AND CONDITIONS OF THE GRANT ASSISTANCE.

A RESOLUTION

To approve and accept a grant in the amount of \$341,164 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to support the FSM Behavioral Risk Factors Surveillance System (BRFSS) program, including all the terms and conditions of the grant assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services, for the FSM Behavioral Risk Factors Surveillance
3 System program, issued a Grant Award on September 24, 2025, to
4 the Government of the Federated States of Micronesia providing
5 funding in the amount of \$341,164 for the purpose of providing
6 support to the FSM BRFSS Program – Advancing equity through
7 improved data collection: engaging underrepresented communities
8 in national surveys; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, requires
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; now, therefore,

13 BE IT RESOLVED by the Twenty-Fourth Congress of the
14 Federated States of Micronesia, Third Regular Session, 2026,
15 that Congress hereby approves and accepts the grant in the
16 amount of \$341,164 from the United States Department of Health
17 and Human Services, Centers for Disease Control and Prevention,
18 including all the terms and conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Secretary of the Department of
4 Justice, the Secretary of the Department of Health and Social
5 Affairs, and the Secretary of the Department of Finance and
