

AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05, 20-15, 20-33, 20-48, 20-63, 20-71, 20-156, 20-175, 21-22, 21-52, 21-146, 21-156, 21-195, 21-213, 21-244, 22-25, 22-62, 22-111, 23-38, 23-55, 23-62, 23-131, 23-150, 24-23, 24-44 and 24-50, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund priority infrastructure projects and other programs for Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-124, as amended by
2 Public Laws Nos. 19-133, 19-140, 20-05, 20-15, 20-33, 20-48,
3 20-63, 20-71, 21-156, 21-195, 21-213, 21-244, 22-25, 22-62,
4 23-150, 24-23, 24-44 and 24-50, is hereby further amended to read
5 as follows:

6 "Section 4. Of the \$11,300,000 appropriated under this
7 act, \$3,000,000 shall be apportioned for priority
8 infrastructure projects and other programs in the state
9 of Pohnpei.

4 Section 2. Section 6 of Public Law No. 19-124, as
 5 amended by Public Laws Nos. 19-133, 19-140, 20-05, 20-15, 20-33,
 6 20-48, 20-63, 20-156, 21-22, 21-146, 21-195, 21-244, 22-111,
 7 23-55, 23-62, 23-131, 24-23, 24-44 and 24-50, is hereby further
 8 amended to read as follows:

9 "Section 6. Allotment and management of funds and
 10 lapse date. All funds appropriated by this act shall
 11 be allotted, managed, administered and accounted for in
 12 accordance with applicable laws, including, but not
 13 limited to, the Financial Management Act of 1979. The
 14 allottee shall be responsible for ensuring that these
 15 funds, or so much thereof as may be necessary, are used
 16 solely for the purpose specified in this act, and that
 17 no obligations are incurred in excess of the sum
 18 appropriated. The allottee of the funds appropriated
 19 under section 2 of this act shall be the Governor of
 20 the State of Yap or his designee. The allottee of the
 21 funds appropriated under sections 3 and 4 of this act
 22 shall be the President of the Federated States of
 23 Micronesia or his designee; PROVIDED THAT, the allottee
 24 of funds appropriated under subsections 3(1)(a) and
 25 3(1)(b) of this act shall be the Governor of Kosrae

1 State or his designee the allottee of funds
2 appropriated under subsection 3(1)(c) of this act shall
3 be the Mayor of Malem Municipal Government or his
4 designee, the allottee of funds appropriated under
5 subsections 4(1)(c), 4(1)(d), 4(1)(e), 4(1)(g),

20 Kitti, the allottee of funds appropriated under
21 subsection 4(3)(ad) of this act shall be the Chief
22 Justice of Madolenihmw or his designee, the allottee of
23 funds appropriated under subsection 4(3)(ae) of this
24 act shall be the Chief Justice of Kitti or his
25 designee; the allottee of funds appropriated under

1 subsection 4(3)(an) of this act shall be the Secretary
2 of the Department of Health and Social Affairs or his
3 designee; the allottee of the funds appropriated under
4 subsections 4(3)(ak) and 4(3)(ao) of this act shall be
5 the Vice President of the Federated States of
6 Micronesia or his designee; the allottee of funds
7 appropriated under subsections 4(3)(al), 4(3)(ap) ,
8 4(3)(au) and 4(3)(av) of this act shall be the
9 Meninkeder Lapalap of Madolenihmw Municipal Government
10 or his designee. The allottee of funds appropriated
11 under sections 5(2) and 5(7) of this act shall be the
12 Governor of Chuuk State or his designee; the allottee
13 of funds appropriated under subsection 5(1)(3) of this
14 act shall be the Mortlock Islands Development Authority
15 (MIDA); the allottee of funds appropriated under
16 subsections 5(1)(o), 5(1)(p) 5(1)(1) and 5(1)(4) of
17 this act shall be the Mayor of Weno Municipal
18 Government or his designee; EXCEPT THAT the allottee of
19 funds appropriated under subsection 5(1)(m) of this act
20 shall be the FSM Telecommunication Corporation; the
21 allottee of funds appropriated under subsection 5(1)(5)
22 of this act shall be the Southern Namoneas Development
23 Authority (SNDA); the allottee of funds appropriated
24 under subsection 5(1)(6) of this act shall be the
25 Faichuk Development Authority. The authority of the

1 allottee to obligate funds appropriated by this act
2 shall lapse on September 30, 2026."

3 Section 3. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.
