AN ACT

To further amend Public Law No. 20-68, as amended by Public Laws Nos. 20-78, 20-89, 20-176, 21-95, 21-138, 21-197, 22-116, 23-88, 23-156 and 24-27, by amending sections 3 and 5 thereof, to change the use, allottee, and lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 20-68, as amended by  
2 Public Law No. 23-156, is hereby further amended to read as  
3 follows:

4 "Section 3. Of the sum of \$1,440,000 appropriated by  
5 this act, \$480,000 is apportioned for public projects  
6 and social programs in the state of Pohnpei.

6 Section 2. Section 5 of Public Law No. 20-68, as amended by  
 7 Public Laws Nos. 20-89, 21-95, 21-138, 22-116, 23-88, 24-10 and  
 8 24-27, is hereby further amended to read as follows:

9 "Section 5. Allotment and management of funds and  
 10 lapse date. All funds appropriated by this act shall  
 11 be allotted, managed, administered and accounted for  
 12 in accordance with applicable laws, including, but not  
 13 limited to, the Financial Management Act of 1979. The  
 14 allottee shall be responsible for ensuring that these  
 15 funds, or so much thereof as may be necessary, are  
 16 used solely for the purpose specified in this act, and  
 17 that no obligations are incurred in excess of the sum  
 18 appropriated. The allottee of the funds appropriated  
 19 under sections 2 and 3 of this act shall be the  
 20 President of the Federated States of Micronesia or his  
 21 designee; PROVIDED THAT the allottee of funds  
 22 appropriated under subsections 2(a), 2(b) and 2(h) of  
 23 this act shall be the Mayor of Lelu Town Government or  
 24 his designee; the allottee of funds appropriated under  
 25 subsections 2(c) to 2(g) of this act shall be the

1 Mayor of Tafunsak Municipal Government or his  
2 designee; the allottee of funds appropriated under  
3 sections 2(i) and 2(j) of this act shall be the Mayor  
4 of Malem Municipal Government or his designee; the  
5 allottee of funds appropriation under subsection  
6 3(1)(i) of this act shall be the Chief Magistrate of  
7 Sokehs Municipal Government or his designee; the  
8 allottee of funds appropriated under subsection  
9 3(2)(a) of this act shall be the President of the COM-  
10 FSM Institute or his designee; the allottee of funds  
11 appropriated under subsection 3(2)(b) of this act  
12 shall be the Pohnpei Transportation Authority; the  
13 allottee of funds appropriated under subsections  
14 3(2)(c) to 3(2)(g), and 3(3)(f) of this act shall be  
15 the Secretary of the Department of Transportation,  
16 Communications and Infrastructure or his designee; the  
17 allottee of funds appropriated under subsections  
18 3(4)(a) shall be the President of the COM-FSM  
19 Institute or his designee; the allottee of funds  
20 appropriated under subsection 3(4)(b) of this act  
21 shall be the Mayor of Pingelap Municipal Government or  
22 his designee; the allottee of funds appropriated under  
23 subsection 3(4)(c) of this act shall be the Mayor of  
24 Mwokilloa Municipal Government or his designee. The  
25 allottee of funds appropriated under subsections 4(1)


1           and 4(6) of this act shall be the Governor of Chuuk  
2           State or his designee. The allottee of funds  
3           appropriated under subsection 4(2) of this act shall  
4           be the Mortlock Islands Development Authority. The  
5           allottee of funds appropriated under subsection 4(3)  
6           of this act shall be the Mayor of Weno Municipal  
7           Government or his designee. The allottee of funds  
8           appropriated under subsection 4(4) of this act shall  
9           be the Southern Namoneas Development Authority. The  
10          allottee of funds appropriated under subsection 4(5)  
11          of this act shall be the Faichuk Development  
12          Authority. The authority of the allottee to obligate  
13          funds appropriated by this act shall lapse on  
14          September 30, 2027."
