
Dear Speaker Moses:

AN ACT

To amend Public Law No. 22-157, as amended by Public Laws Nos 22-179, 22-205, 23-91, 23-141 and 24-25, by amending sections 3 and 6 thereof, to change the use and lapse date of fund previously appropriated therein, to fund public projects and social programs for the people of Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 22-157, is hereby
2 amended to read as follows:

3 "Section 3. Of the \$2,800,000 appropriated under this act,
4 \$400,000 shall be apportioned for public projects and social
5 programs for the people of Kosrae State.

13 Section 2. Section 6 of Public Law No. 22-157, as amended by
 14 Public Laws Nos. 22-179, 23-91 and 24-25, is hereby further
 15 amended to read as follows:

16 "Section 6. Allotment and management of funds and lapse
 17 date. All funds appropriated by this act shall be
 18 allotted, managed, administered and accounted for in
 19 accordance with applicable laws, including, but not
 20 limited to, the Financial Management Act of 1979. The
 21 allottee shall be responsible for ensuring that these
 22 funds, or so much thereof as may be necessary, are used
 23 solely for the purpose specified in this act, and that
 24 no obligations are incurred in excess of the sum
 25 appropriated. The allottee of the funds appropriated

1 under section 2 of this act shall be the Governor of Yap
2 State or his designee. The allottee of funds
3 appropriated under sections 3 and 4 of this act shall be
4 the President of the Federated States of Micronesia or
5 his designee; EXCEPT THAT, the allottee of funds
6 appropriated under section 3(1) of this act shall be the
7 Governor of Kosrae State or his designee; the allottee
8 of funds appropriated under section 3(2) of this act
9 shall be the Mayor of Lelu Town Government or his
10 designee; the allottee of funds appropriated under
11 subsections 4(1)a, 4(1)(b), 4(1)(c), 4(2)(a), 4(2)(b),
12 4(2)(d), 4(2)(g), 4(2)(i), 4(3)(c), 4(3)(e) and 4(3)(k)
13 of this act shall be the Secretary of the Department of
14 Transportation, Communications and Infrastructure or his
15 designee; the allottee of funds appropriated under
16 subsections 4(2)(c) and 4(3)(b) of this act shall be the
17 Secretary of Health and Social Affairs or her designee;
18 the allottee of funds appropriated under subsection
19 4(2)(e) of this act shall be the President of COM-FSM;
20 the allottee of funds appropriated under subsection
21 4(2)(f) of this act shall be the FSM NOC; the allottee
22 of funds appropriated under subsections 4(1)(d),
23 4(1)(e), 4(2)(h) of this act shall be the Secretary of
24 the Department of Education or his designee; the
25 allottee of funds appropriated under subsections

1 4(3)(a), 4(3)(d), 4(3)(f) and 4(3)(g) of this act shall
2 be the Pohnpei Transportation Authority (PTA); the
3 allottee of funds appropriated under subsections 4(3)(h)
4 of this act shall be the Pohnpei Utility Corporation
5 (PUC); the allottee of funds appropriated under sections
6 4(3)(j) and 4(3)(n) of this act shall be the Meninkeder
7 Lapalap of Madolenihmw; the allottee of funds
8 appropriated under section 4(3)(m) of this act shall be
9 the Vice President of the Federated States of Micronesia
10 or his designee; the allottee of funds appropriated
11 under section 4(3)(l) of this act shall be the Secretary
12 of the Department of Education or his designee;. The
13 allottee of the funds appropriated under subsections
14 5(1) and 5(6) of this act shall be the Governor of Chuuk
15 State or his designee; the allottee of the funds
16 appropriated under subsection 5(2) of this act shall be
17 the Mortlocks Island Development Authority (MIDA); the
18 allottee of the funds appropriated under subsection 5(3)
19 of this act shall be the Mayor of Weno Municipal
20 Government or his designee; the allottee of the funds
21 appropriated under subsection 5(4) of this act shall be
22 the Southern Namoneas Development Authority; the
23 allottee of the funds appropriated under subsection 5(5)
24 of this act shall be the Faichuk Development Authority.
25 The authority of the allottee to obligate funds

1 appropriated by this act shall lapse on September 30,
2 2027.”

3 Section 3. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.
