
Dear Speaker Moses:

AN ACT

To further amend Public Law No. 23-122, as amended by Public Laws Nos. 23-138, 23-146, 24-06 and 24-29, by amending sections 4 and 6 thereof, for the purpose of changing the use and lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 23-122, as amended by
2 Public Law No. 24-06, is hereby further amended to read as follows:

3 "Section 4. Of the \$1,680,000 appropriated under this
4 act, \$480,000 shall be apportioned to fund public
5 projects and social programs for the people of
6 Pohnpei.

6 Section 2. Section 6 of Public Law No. 23-122, as amended
 7 by Public Law No. 23-138, is further hereby amended, to read as
 8 follows:

9 "Section 6. Allotment and management of funds and
 10 lapse date. All funds appropriated by this act shall
 11 be allotted, managed, administered and accounted for
 12 in accordance with applicable laws, including, but not
 13 limited to, the Financial Management Act of 1979. The
 14 allottee shall be responsible for ensuring that these
 15 funds, or so much thereof as may be necessary, are
 16 used solely for the purpose specified in this act, and
 17 that no obligations are incurred in excess of the sum
 18 appropriated. The allottee of the funds appropriated
 19 under section 2 of this act shall be the Governor of
 20 Yap or his designee. The allottee of the funds
 21 appropriated under subsection 3(1) of this act shall
 22 be the Governor of Kosrae or his designee. The
 23 allottee of the funds appropriated under subsection
 24 3(2) of this act shall be the Mayor of Lelu Town
 25 Government or his designee. The allottee of the funds


1 appropriated under section 4 of this act shall be the
2 President of the Federated States of Micronesia or his
3 designee. EXCEPT THAT, the allottee of funds
4 appropriated under section 4(2)(a) of this act shall
5 be the Mayor of Sapuwuafik Municipal Government or his
6 designee; the allottee of funds appropriated under
7 section 4(2)(b) of this act shall be the Mayor of
8 Nukuoro Municipal Government or his designee; the
9 allottee of funds appropriated under section 4(2)(c)
10 of this act shall be the Mayor of Kapingamarangi
11 Municipal Government or his designee; the allottee of
12 funds appropriated under section 4(2)(k) of this act
13 shall be the Mayor of Sokehs Municipal Government or
14 his designee; the allottee of funds appropriated under
15 sections 4(2)(d), 4(2)(e), 4(2)(f), 4(2)(g), 4(2)(h),
16 4(2)(i), 4(2)(j), 4(2)(l) and 5(6)(a) of this act
17 shall be the Secretary of Transportation,
18 Communications and Infrastructure or his designee.
19 The allottee of the funds appropriated under
20 subsections 5(1) and 5(6) of this act shall be the
21 Governor of Chuuk State or his designee; the allottee
22 of the funds appropriated under subsection 5(2) of
23 this act shall be the Mortlocks Island Development
24 Authority (MIDA); the allottee of the funds
25 appropriated under subsection 5(3) of this act shall

1 be the Mayor of Weno Municipal Government or his
2 designee; the allottee of the funds appropriated under
3 subsection 5(4) of this act shall be the Southern
4 Namoneas Development Authority; the allottee of the
5 funds appropriated under subsection 5(5) of this act
6 shall be the Faichuk Development Authority. The
7 authority of the allottee to obligate funds
8 appropriated by this act shall lapse on September 30,
9 2027.”

10 Section 3. This act shall become law upon approval by the
11 President of the Federated States of Micronesia or upon its
12 becoming law without such approval.
