AN ACT

To further amend Public Law No. 22-180, as amended by Public Laws Nos. 22-187, 22-188, 23-03, 23-09, 23-11, 23-36, 23-59, 23-118, 23-124, 23-139, 23-145, 24-16 and 24-19, by amending sections 4 and 6 thereof, for the purpose of changing the use, allottee and lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei, and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 22-180, as
2 amended by Public Laws Nos. 22-188, 22-09, 23-11, 23-36,
3 23-118, 23-145, 24-16 and 24-19, is hereby further amended
4 to read as follows:

5 "Section 4. Of the \$8,820,000 appropriated under this
6 act, \$2,520,000 shall be apportioned for public projects
7 and social programs for the people of Pohnpei State.

14 Section 2. Section 6 of Public Law No. 22-180, as
 15 amended by Public Laws Nos. 22-188, 23-11, 23-36, 23-118,
 16 23-124, 23-139, 24-16 and 24-19, is hereby further amended
 17 to read as follows:

18 "Section 6. Allotment and management of funds and
 19 lapse date. All funds appropriated by this act shall
 20 be allotted, managed, administered and accounted for
 21 in accordance with applicable laws, including, but not
 22 limited to, the Financial Management Act of 1979. The
 23 allottee shall be responsible for ensuring that these
 24 funds, or so much thereof as may be necessary, are
 25 used solely for the purpose specified in this act, and

1 that no obligations are incurred in excess of the sum
2 appropriated. The allottee of the funds appropriated
3 under section 2 of this act shall be the Governor of
4 Yap State or his designee. The allottee of funds
5 appropriated under sections 3 and 4 of this act shall
6 be the President of the Federated States of Micronesia
7 or his designee; EXCEPT THAT, the allottee of funds
8 appropriated under section 3(1) of this act shall be
9 the Governor of Kosrae State or his designee; the
10 allottee of funds appropriated under section 3(2) of
11 this act shall be the Mayor of Lelu Town Government or
12 his designee; PROVIDED THAT, the allottee of funds
13 appropriated under subsection 3(2)(x) of this act
14 shall be the Mayor of Utwe Municipal Government or his
15 designee; the allottee of funds appropriated under
16 subsection 3(2)(y) of this act shall be the Mayor of
17 Malem or his designee; the allottee of funds
18 appropriated under subsections 4(1)(b), 4(1)(k),
19 4(1)(l), 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d), 4(2)(e),
20 4(2)(g), 4(2)(h), 4(2)(p), 4(2)(s), 4(2)(t), 4(2)(u),
21 4(2)(v), 4(3)(q) [~~and~~], 4(2)(aa), 4(3)(a) 4(2)(ab) and
22 4(3)(s) of this act shall be the Secretary of the
23 Department of Transportation, Communications and
24 Infrastructure or his designee; the allottee of funds
25 appropriated under subsections 4(1)(a), 4(1)(j),

1 4(2)(f), 4(2)(j), 4(2)(k), 4(2)(l), 4(2)(m), 4(2)(r),
2 4(2)(x), 4(3)(m), 4(3)(n), 4(2)(n), 4(3)(u) and
3 4(3)(t) of this act shall be the Pohnpei
4 Transportation Authority (PTA); the allottee of funds
5 appropriated under subsection 4(2)(i) of this act
6 shall be the Secretary of the Department of Education
7 or her designee; the allottee of funds appropriated
8 under subsection 4(2)(o) of this act shall be the
9 Pohnpei Port Authority (PPA); the allottee of funds
10 appropriated under subsections 4(2)(w), 4(2)(q) and
11 4(2)(z) of this act shall be the Mayor of Sapwuahfik
12 Municipal Government or his designee, the allottee of
13 funds appropriated under subsections 4(2)(ac) and
14 4(2)(ad) of this act shall be the Sokehs Municipal
15 Government; the allottee of funds appropriated under
16 section 4(3)(e) of this act shall be the Secretary of
17 the Department of Health and Social Affairs; the
18 allottee of the funds appropriated under subsections
19 5(1) and 5(6) of this act shall be the Governor of
20 Chuuk State or his designee; the allottee of the funds
21 appropriated under subsection 5(2) of this act shall
22 be the Mortlocks Island Development Authority (MIDA);
23 the allottee of the funds appropriated under
24 subsection 5(3) of this act shall be the Mayor of Weno
25 Municipal Government or his designee; the allottee of

1 the funds appropriated under subsection 5(4) of this
2 act shall be the Southern Namoneas Development
3 Authority; the allottee of the funds appropriated
4 under subsection 5(5) of this act shall be the Faichuk
5 Development Authority. The authority of the allottee
6 to obligate funds appropriated by this act shall lapse
7 on September 30, 2027."

8 Section 3. This act shall become law upon approval by the
9 President of the Federated States of Micronesia or upon its
10 becoming law without such approval.
