AN ACT

To further amend Public Law No. 19-121, as amended by Public Laws Nos. 19-130 and 19-142, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 19-121, as amended by
2 Public Laws Nos. 19-130 and 19-142, is hereby further amended to
3 read as follows:

4 "Section 3. Of the sum of \$5,450,000 appropriated by this
5 act, \$1,100,000 is apportioned to fund public projects and
6 social programs for the people of the state of Kosrae.

23 Section 2. Section 6 of Public Law No. 19-121, as amended by
 24 Public Laws Nos. 19-130 and 19-142, is hereby amended to read as
 25 follows:

1 "Section 6. Allotment and management of funds and
2 lapse date. All funds appropriated by this act shall
3 be allotted, managed, administered and accounted for
4 in accordance with applicable laws, including, but
5 not limited to, the Financial Management Act of 1979.
6 The allottee shall be responsible for ensuring that
7 these funds, or so much thereof as may be necessary,
8 are used solely for the purpose specified in this
9 act, and that no obligations are incurred in excess
10 of the sum appropriated. The allottee of the funds
11 appropriated under section 2 of this act shall be the
12 Governor of Yap State; PROVIDED THAT, the allottee of
13 funds appropriated under section 2(k) shall be the
14 President of the Federated States of Micronesia. The
15 allottee of funds appropriated under sections 3 and 4
16 of this act shall be the President of the Federated
17 States of Micronesia or his designee; PROVIDED THAT
18 the allottee of funds appropriated under subsections
19 3(a) through 3(z) - shall be the Mayor of Tafunsak
20 Municipal Government; the allottee of funds
21 appropriated under subsections 3(aa) - 3(all) shall
22 be the Mayor of Utwe Municipal Government or his
23 designee; the allottee of funds appropriated under
24 subsections 4(1)(1), 4(3)(a), 4(3)(f) and 4(3)(i) of
25 this act shall be the Pohnpei Transportation


1 Authority (PTA); the allottee of funds appropriated
2 under subsections 4(2)(a), 4(2)(d), 4(2)(e), 4(2)(f),
3 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j), 4(2)(k), 4(2)(l)
4 and 4(2)(m) shall be the Secretary of the Department
5 of Transportation, Communications and Infrastructure
6 or his designee; the allottee of funds appropriated
7 under subsection 4(2)(b) shall be the Pohnpei Utility
8 Corporation (PUC); the allottee of funds appropriated
9 under subsection 4(2)(c) shall be the Office of
10 Fisheries, Pohnpei State; the allottee of funds
11 appropriated under subsection 4(2)(n) shall be the
12 Secretary of the Department of Education or his
13 designee; the allottee of funds appropriated under
14 subsection 4(3)(b) shall be the Governor of the State
15 of Pohnpei or his designee; the allottee of funds
16 appropriated under subsections 4(3)(c) and 4(3)(e) of
17 this act shall be the Meninkeder of Madolenihmw;
18 allottee of funds appropriated under subsections
19 4(3)(d) and 4(3)(m) shall be the Luhkenmoanlap of
20 Kitti. The allottee of funds appropriated under
21 subsections 5(1), 5(3) and 5(6) of this act shall be
22 the Governor of Chuuk State or his designee. The
23 allottee of funds appropriated under subsection 5(2)
24 of this act shall be the Mortlock Islands Development
25 Authority. The allottee of funds appropriated under

1 subsection 5(4) of this act shall be the Southern
2 Namoneas Development Authority. The allottee of
3 funds appropriated under subsection 5(5) of this act
4 shall be the Faichuk Development Authority. The
5 authority of the allottee to obligate funds
6 appropriated by this act shall lapse on September 30,
7 2018."

8 Section 3. This act shall become law upon approval by the
9 President of the Federated States of Micronesia or upon its
10 becoming law without such approval.
