

AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106, 19-128, 19-134 and 19-138, by amending sections 1 and 2 thereof, to change the use and allottee of funds previously appropriated for public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 18-11, as amended
2 by Public Laws Nos. 18-44, 19-128 and 19-134, is hereby further
3 amended to read as follows:

4 "Section 1. The sum of \$1,680,000, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2013, for the
8 purpose of funding public projects and social programs
9 in the states of Pohnpei and Yap. The funds shall be
10 apportioned as follows:

11 (1) Pohnpei State \$ 1,130,000

12 PROVIDED, HOWEVER, that the funds appropriated in
13 subsections (b)(c)(d) and (e) of this section shall
14 not be allotted until Congress is officially advised
15 that funds improperly disbursed as a result of the
16 line item veto which was reflected in Public Law No.
17 18-11 are collected.

25 Section 2. Section 2 of Public Law No. 18-11, as amended

1 by 18-44, 18-81, 19-33, 19-128 and 19-138, is hereby further
2 amended to read as follows:


3 "Section 2. Allotment and management of funds and
4 lapse date. All funds appropriated by this act shall
5 be allotted, managed, administered and accounted for
6 in accordance with applicable laws, including, but not
7 limited to, the Financial Management Act of 1979. The
8 allottee shall be responsible for ensuring that these
9 funds, or so much thereof as may be necessary, are
10 used solely for the purpose specified in this act, and
11 that no obligations are incurred in excess of the sum
12 appropriated. The allottee of the funds appropriated
13 under subsection 1 of section 1 of this act shall be
14 the President of the Federated States of Micronesia or
15 his designee; PROVIDED THAT, the allottee of funds
16 appropriated under subsections 1(b)(vi) 1(d)(i) and
17 1(d)(ii) 1(d)(iii) of this act shall be the Pohnpei
18 Transportation Authority (PTA); the allottee of funds
19 appropriated under subsection 1(b)(v) of this act
20 shall be the Governor of the State of Pohnpei or his
21 designee; the allotte of funds appropriated under
22 subsections 1(b)(i), 1(b)(ii), 1(b)(iii) 1(b)(vii),
23 and 1b(b)(viii) shall be the Secretary of the
24 Department of Transportation, Communications and
25 Infrastructure or his designee. The allottee of funds

1 appropriated under subsection 2 of section 1 of this
2 act shall be the Governor of the State of Yap or his
3 designee. The authority of the allottee to obligate
4 funds appropriated by this act shall lapse on
5 September 30, 2018."

6 Section 3. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its
8 becoming law without such approval.
