

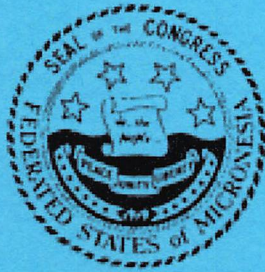

AN ACT

To further amend Public Law No. 19-152, as amended by Public Laws Nos. 19-162 and 20-08, by amending section 2 thereof, to change the use of certain funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 19-152, as amended
2 by Public Law No. 19-162, is hereby further amended to read as
3 follows:


4 "Section 2. Of the sum of \$700,000 appropriated by
5 this act, \$100,000 is apportioned for Yap State for
6 public projects and social programs.


