
Dear Speaker Simina:

AN ACT

To further amend Public Law No. 19-64, as amended by Public Laws Nos. 19-81, 19-97, 19-120 and 19-137, by amending sections 1 and 2 thereof, to change the use and lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in the states of Kosrae and Pohnpei, to correct technical errors, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 19-64, as amended
2 by Public Laws Nos. 19-81, 19-97 and 19-120, is hereby further
3 amended to read as follows:

4 "Section 1. Purpose. The sum of \$3,050,000, or so much
5 thereof as may be necessary, is hereby appropriated from
6 the General Fund of the Federated States of Micronesia
7 for the fiscal year ending September 30, 2016, for the
8 purpose of funding public projects and social programs
9 in the states of Kosrae and Pohnpei. The funds
10 appropriated under this section shall be apportioned as
11 follows:

5 Section 2. Section 2 of Public Law No. 19-64, as amended
 6 by Public Laws Nos. 19-81 and 19-97, is hereby further amended
 7 to read as follows:

8 "Section 2. Allotment and management of funds and
 9 lapse date. All funds appropriated by this act shall
 10 be allotted, managed, administered and accounted for
 11 in accordance with applicable laws, including, but
 12 not limited to, the Financial Management Act of 1979.
 13 The allottee shall be responsible for ensuring that
 14 these funds, or so much thereof as may be necessary,
 15 are used solely for the purpose specified in this
 16 act, and that no obligations are incurred in excess
 17 of the sum appropriated. The allottee of the funds
 18 appropriated under section 1 of this act shall be the
 19 President of the Federated States of Micronesia or
 20 his designee; PROVIDED THAT, the funds appropriated
 21 under subsections 1(d) shall be the Mayor of Lelu
 22 Town Government or his designee; the allottee of
 23 funds appropriated under subsections 1(2)(1)(a)-(o),
 24 1(2)(2)(a), 1(2)(2)(c), 1(2)(3)(a), 1(2)(3)(b),
 25 1(2)(3)(d), 1(2)(3)(f) - (j), 1(2)(3)(l), 1(2)(3)(n),

1 1(2)(3)(q), 1(2)(4)(a)-(j) shall be the Pohnpei
2 Transportation Authority (PTA); the allottee of funds
3 appropriated under subsections 1(2)(2)(b),
4 1(2)(2)(d), 1(2)(2)(e) and 1(2)(2)(f) shall be the
5 Secretary of the Department of Transportation,
6 Communication and Infrastructure or his designee; the
7 allottee of funds appropriated under subsections
8 1(2)(2)(g), 1(2)(2)(h) and 1(2)(3)(m) shall be the
9 Pohnpei Utility Corporation; the allottee of fund
10 appropriated under subsections 1(2)(4)(k)-(s) shall
11 be the Governor of the State of Pohnpei. The
12 authority of the allottee to obligate funds
13 appropriated by this act shall lapse on September 30,
14 2018."


