CONGRESSIONAL ACT NO. 21-60, ENTITLED: "AN ACT TO AMEND SECTIONS 1, 2, 3, 8, 9, AND 12 OF PUBLIC LAW NO. 21-42, TO APPROPRIATE \$2,327,210 OF ADDITIONAL FUNDS FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2020, TO PROVIDE SUPPLEMENTAL FUNDING FOR THE OPERATIONS OF THE NATIONAL GOVERNMENT OF THE FEDERATED STATES OF MICRONESIA, VARIOUS PROGRAMS, GRANTS, SUBSIDIES AND CONTRIBUTIONS, AND CAPITAL AND HUMAN RESOURCES DEVELOPMENT; TO CHANGE THE ALLOTTEE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED; AND FOR OTHER PURPOSES."

I take this opportunity to express my personal appreciation for the hard work of the 21st FSM Congress, especially you, your members and staff, during the deliberation and the eventual passage of the supplemental budget.

On a final note, I have decided to item veto line 25 of page 7 because this travel funding of the Office of Personnel is already spent partially. Deleting the entire funding this time will negatively impact upon the operation of the Office. I would urge Congress to reconsider its decision. Thank you.



AN ACT

To amend sections 1, 2, 3, 8, 9, and 12 of Public Law No. 21-42, to appropriate \$2,327,210 of additional funds from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, to provide supplemental funding for the operations of the National Government of the Federated States of Micronesia, various programs, grants, subsidies and contributions, and Capital and Human Resources Development; to change the allottee of certain funds previously appropriated; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 21-42 is hereby
2 amended to read as follows:

3 Purpose. The purpose of this act is to appropriate the
4 sum of \$64,390,358 from the General Fund of the
5 Federated States of Micronesia for the fiscal year
6 ending September 30, 2020, for the purpose of funding
7 the operations of all branches of the National
8 Government of the Federated States of Micronesia, its
9 agencies, various programs, grants, subsidies and
10 contributions and Capital and Human Resources
11 Development. The National Government's share of the
12 Amended Compact funds has been reduced to zero; EXCEPT
13 THAT; the National Government will retain the Compact
14 Sector Grant amount for COM-FSM and 10 percent of the
15 Supplemental Education Grant funds as is reflected in
16 the budget for the Department of Education. The sum
17 appropriated herein shall be apportioned as follows:"

1 Section 2. Section 2 of Public Law No. 21-42 is hereby
 2 amended to read as follows:

3 "Section 2. Operating Expenses of the Executive Branch.

4 The sum of \$23,740,622, or so much thereof as may be
 5 necessary, is hereby appropriated from the General Fund
 6 of the Federated States of Micronesia for the fiscal

10 accordance with applicable law, including, but not

12 (b) The allottees shall be responsible for
13 ensuring that these funds, or so much thereof as may
14 be necessary, are used solely for the purposes
15 specified in this act, and that no obligations are
16 incurred in excess of the sums appropriated.

17 (2) Allottees. The allottees of the funds
18 appropriated by this act are as follows:

19 (a) Section 2 - the allottee of these funds shall

21 Micronesia;

22 (b) Section 3 - the allottee of these funds shall

9 following subsections of sections 8 through 9 of this
10 act:

11 (i) Sections 8(1)(f) and 8(13)(q) – the
12 allottee of these funds shall be the Chair of the
13 Joint Committee on Compact Review and Planning;

14 (ii) Section 8(8)(a) – the allottee of these
15 funds shall be the Governor of the state of Kosrae;

16 (iii) Section 8(8)(b) – the allottee of these
17 funds shall be the Governor of the state of Pohnpei;

18 (iv) Section 8(8)(c) – the allottee of these
19 funds shall be the Governor of the state of Chuuk;

20 (v) Section 8(8)(d) – the allottee of these
21 funds shall be the Governor of the state of Yap;

22 (vi) Section 8(11) – the allottee of these
23 funds shall be the Public Auditor of the Federated
24 States of Micronesia;

25 (vii) Section 8(12) – the allottee of these

1 funds shall be the Speaker of the Congress of the
2 Federated States of Micronesia;

3 (viii) Section 8(13)(a) – the allottee of
4 these funds shall be the President of the College of
5 Micronesia-FSM;

6 (ix) Section 8(13)(d) through (g) – the
7 allottee of these funds shall be the Chief Justice of
8 the respective State Supreme Court;

9 (x) Section 8(13)(h) – the allottee of
10 these funds shall be the Chief Justice of the Supreme
11 Court of the Federated States of Micronesia

12 (xi) Section 9(1) – the allottee of these
13 funds shall be the President of the College of
14 Micronesia-FSM;

15 (xii) Section 9(3)(b) – the allottee of
16 these funds shall be the Governor of the state of
17 Kosrae;

18 (xiii) Section 9(3)(c) – the allottee of
19 these funds shall be the Governor of the state of
20 Pohnpei;

21 (xiv) Section 9(3)(d) – the allottee of
22 these funds shall be the Governor of the state of
23 Chuuk;

24 (xv) Section 9(3)(e) – the allottee of
25 these funds shall be the Governor of the state of Yap;

1 (xvi) Section 8(13)(t) - the allottee of
2 these funds shall be the National Olympic Committee;

3 (xvii) Section 8(13)(u) - the allottee of
4 these funds shall be the Principal of Saint Cecilia
5 Catholic School.

6 (xviii) Section 9(12)(d) - the allottee of
7 these funds shall be the President of the
8 Constitutional Convention.

9 (3) Lapse date. The authority of the allottees to
10 obligate funds appropriated by this act shall lapse as
11 of September 30, 2020; PROVIDED, HOWEVER, that the
12 funds appropriated under section 9 of this act shall
13 not lapse."

14 Section 7. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its
16 becoming law without such approval.
