AN ACT

To amend Public Law No. 20-155, as amended by Public Laws Nos. 20-177 and 20-188, by amending section 2 thereof, for the purpose of changing the use of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 20-155, as amended by  
2 Public Law No. 20-177, is hereby further amended to read as  
3 follows:

4 "Section 2. Of the \$1,400,000 appropriated under this  
5 act, \$200,000 shall be apportioned for public projects  
6 and social programs for the people of Yap State.

8 (a) Fal Village, Rumung Bridge ..... 45,000

9 (b) Expenses for deceased/

10 human remains; PROVIDED THAT, of the \$100,000

11 in this line item, \$40,000 is earmarked for

13 remains from Philippines, Honolulu,

14 and Guam to Yap ..... 100,000

15 (c) Yap Delegation Office

16 outreach/travel needs ..... 55,000"
