AN ACT

To further amend Public Law No. 20-141, as amended by Public Laws Nos. 20-145, 20-163, 20-164, 20-190, 21-05, 21-33 and 21-48, by amending sections 3, 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other projects and programs in the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 20-141, as amended by

 15 Public Laws Nos. 20-163, 20-190, 21-05, 21-33 and 21-48, is hereby
 16 further amended to read as follows:

17 "Section 6. Allotment and management of funds and lapse
 18 date. All funds appropriated by this act shall be
 19 allotted, managed, administered and accounted for in
 20 accordance with applicable laws, including, but not
 21 limited to, the Financial Management Act of 1979. The
 22 allottee shall be responsible for ensuring that these
 23 funds, or so much thereof as may be necessary, are used
 24 solely for the purpose specified in this act, and that
 25 no obligations are incurred in excess of the sum

1 appropriated. The allottee of the funds appropriated
2 under section 2 of this act shall be the Governor of Yap
3 State or his designee PROVIDED THAT the allottee of
4 funds appropriated under subsections 2(a) and 2(b) of
5 this act shall be the President of the Federated States
6 of Micronesia or his designee. The allottee of the
7 funds appropriated under sections 3 and 4 of this act
8 shall be the President of the Federated States of
9 Micronesia or his designee; PROVIDED THAT, the allottee
10 of funds appropriated under subsections 3(a), 3(b),
11 3(c), 3(e), 3(f), 3(g), 3(h), 3(j), 3(k), 3(l), 3(m),
12 3(n), 3(o), 3(p), 3(q), 3(s), 3(t), 3(u), 3(v), 3(w),
13 3(x), 3(y), 3(z), 3(a3) to 3(a10), 3(a30) and 3(a31) of
14 this act shall be the Mayor of Lelu Town Government or
15 his designee; the allottee of funds appropriated under

17 of this act shall be the Mayor of Tafunsak Municipal
18 Government or his designee; the allottee the allottee of
19 funds appropriated under subsections (a27), (a28) and

21 or his designee; the allottee of funds appropriated
22 under subsection 3(a26) is the Secretary of the FSM
23 Department of Education or his designee; the allottee of

4 Authority; the allottee of funds appropriated under
5 subsection 4(2)(aa) of this act shall be the Secretary
6 of the Department of Resources and Development or his
7 designee; the allottee of fund appropriated under
8 subsections 4(1)(a2) and 4(4)(1) of this act shall be
9 the Mayor of Pingelap Municipal Government; the allottee
10 of funds appropriated under subsections 4(1)(a1) and
11 4(4)(m) of this act shall be the Chief Magistrate of
12 Mwoakilloa Municipal Government; the allottee of funds
13 appropriated under subsection 4(1)(a3) of this act shall
14 be the Luhken Kolwof of Sapuwafik Municipal Government;
15 the allottee of funds appropriated under subsection
16 4(1)(a4) of this act shall be the Mayor of Nukuoro
17 Municipal Government; the allottee of funds appropriated
18 under subsection 4(1)(a5) of this act shall be the Chief
19 Magistrate of Kapingamarangi Municipal Government; the
20 allottee of funds appropriated under subsections
21 4(3)(e), 4(3)(f), 4(3)(j), 4(3)(p), 4(3)(w) and 4(3)(z)
22 of this act shall be the Menin Keder Lapalap of
23 Madolenihmw; the allottee of funds appropriated 4(3)(a5)
24 shall be the Secretary of the Department of Health and
25 Social Affairs. The allottee of the funds appropriated

1 sections 5 of this act shall be the Governor of Chuuk
2 State or his designee; PROVIDED THAT, the allottee of
3 funds appropriated under subsections 5(g) and 5(j) of
4 this act shall be the FSM Telecommunication Corporation
5 or its designee. The authority of the allottee to
6 obligate funds appropriated by this act shall lapse on
7 September 30, 2021."

8 Section 4. This act shall become law upon approval by the
9 President of the Federated States of Micronesia or upon its
10 becoming law without such approval.
