AN ACT

To further amend Public Law No. 21-43, as amended by Public Law No. 21-54, by amending section 6 thereof, to change the allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-43, as amended by
2 Public Law No. 21-54, is hereby further amended to read as
3 follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that no
12 obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee; PROVIDED THAT, the allottee of
16 funds appropriated under subsection 2(f) of this act shall
17 be the President of the COM-FSM. The allottee of funds
18 appropriated under sections 3 and 4 of this act shall be

1 the President of the Federated States of Micronesia or his
2 designee; PROVIDED THAT, the allottee of funds
3 appropriated under subsection 3(1) of this act shall be
4 the Governor of Kosrae State or his designee; the allottee
5 of funds appropriated under subsection 3(2) of this act
6 shall be the Mayor of Lelu Town Government or his
7 designee. The allottee of funds appropriated under section
8 4(1) and 4(3)(1) of this act shall be the Vice President;
9 The allottee of funds appropriated under subsection
10 4(1)(a) and section 4(2) of this act shall be the
11 Secretary of the Department of Transportation,
12 Communications and Infrastructure or his designee, except
13 that the allottee of funds appropriated under subsections
14 4(2)(e), 4(4)(j), 4(4)(k), 4(4)(l) and 4(4)(m) of this act
15 shall be the Pohnpei Transportation Authority (PTA); the
16 allottee of funds appropriated under subsections 4(2)(l),
17 4(3)(d) and 4(3)(f) of this act shall be the Secretary of
18 the Department of Education or his designee; the allottee
19 of funds appropriated under subsection 4(2)(h) of this act
20 shall be the President of COM-FSM; the allottee of funds
21 appropriated under subsections 4(3)(a), 4(3)(b), 4(3)(e),
22 4(3)(h), 4(3)(i) and 4(3)(k) of this act shall be the
23 Meninkeder of Madolenihmw; the allottee of funds
24 appropriated under subsection 4(3)(c) of this act shall be
25 the Chief Justice of Madolenihmw Municipal Government; the

1 allottee of funds appropriated under subsection 4(3)(g) of
2 this act shall be the Luhkenmoanlap of Kitti; the allottee
3 of funds appropriated under subsection 4(3)(j) of this act
4 shall be the Speaker of Isokonedi of Kitti; the allottee
5 of funds appropriated under subsection 4(3)(m) of this act
6 shall be the Director of Pohnpei Public Safety. The
7 allottee of the funds appropriated under sections 5(1),
8 5(3) and 5(6) of this act shall be the Governor of Chuuk
9 State or his designee; the allottee of the funds
10 appropriated under subsection 5(2) of this act shall be
11 the Mortlocks Island Development Authority (MIDA); the
12 allottee of the funds appropriated under subsection 5(4)
13 of this act shall be the Southern Namoneas Development
14 Authority; the allottee of the funds appropriated under
15 subsection 5(5) of this act shall be the Faichuk
16 Development Authority. The authority of the allottee to
17 obligate funds appropriated by this act shall lapse on
18 September 30, 2022.”

2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


