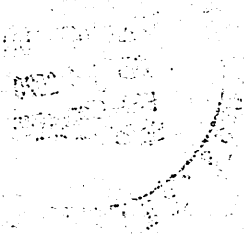

AN ACT

To appropriate the sum of \$1,680,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,680,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2020, for the purpose of funding public projects and
5 social programs for the people of Yap, Kosrae, Pohnpei and Chuuk
6 states. The funds appropriated under this section shall be
7 apportioned as follows:

8 Section 2. Of the \$1,680,000 appropriated under this act,
9 \$240,000 shall be apportioned for public projects and social
10 programs for the people of Yap State.

12 Section 6. Allotment and management of funds and lapse date.

13 All funds appropriated by this act shall be allotted, managed,

14 administered and accounted for in accordance with applicable laws,

15 including, but not limited to, the Financial Management Act of

16 1979. The allottee shall be responsible for ensuring that these

17 funds, or so much thereof as may be necessary, are used solely for

18 the purpose specified in this act, and that no obligations are

19 incurred in excess of the sum appropriated. The allottee of the

20 funds appropriated under section 2 of this act shall be the

21 Governor of Yap State or his designee. The allottee of funds

22 appropriated under sections 3 and 4 of this act shall be the

23 President of the Federated States of Micronesia or his designee;

24 PROVIDED THAT the allottee of funds appropriated under subsections

25 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d), 4(2)(e), 4(2)(f), 4(2)(g) and

1 4(2)(h) of this act shall be the Secretary of the Department of
 2 Transportation, Communications and Infrastructure; the allottee of
 3 funds appropriated under subsection 4(2)(i) of this act shall be
 4 the Chief Magistrate of Sokehs Municipal Government; the allottee
 5 of funds appropriated under subsections 4(3)(a) of this act shall
 6 be the Pohnpei Transportation Authority (PTA); the allottee of
 7 funds appropriated under subsection 4(3)(e) of this act shall be
 8 the Vice President of the Federated States of Micronesia or his
 9 designee; the allottee of funds appropriated under subsections
 10 4(3)(b), 4(3)(c), and 4(3)(d) of this act shall be the Meninkeder
 11 of Madolenihmw. The allottee of the funds appropriated under
 12 subsections 5(1) and 5(6) of this act shall be the Governor of
 13 Chuuk State or his designee; the allottee of the funds
 14 appropriated under subsection 5(2) of this act shall be the
 15 Mortlocks Island Development Authority (MIDA), the allottee of
 16 funds appropriated under section 5(3) of this act shall be the
 17 Mayor of Weno Municipal Government or his designee; the allottee
 18 of the funds appropriated under subsection 5(4) of this act shall
 19 be the Southern Namoneas Development Authority; the allottee of
 20 the funds appropriated under subsection 5(5) of this act shall be
 21 the Faichuk Development Authority. The authority of the allottee
 22 to obligate funds appropriated by this act shall lapse on
 23 September 30, 2022.

1 Section 7. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.


