AN ACT

To further amend Public Law No. 21-80, as amended by Public Laws Nos. 21-99, 21-110 and 21-143, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 21-80, as amended by
2 Public Law No. 21-143, is hereby further amended to read as
3 follows:

4 "Section 4. Of the \$4,200,000 appropriated under this
5 act, \$1,200,000 shall be apportioned for public projects
6 and social programs for the people of Pohnpei State.

19 Section 2. Section 6 of Public Law No. 21-80, as amended by
 20 Public Laws Nos. 21-99, 21-110 and 21-143, is hereby further
 21 amended to read as follows:

22 "Section 6. Allotment and management of funds and lapse
 23 date. All funds appropriated by this act shall be
 24 allotted, managed, administered and accounted for in
 25 accordance with applicable laws, including, but not

1 limited to, the Financial Management Act of 1979. The
2 allottee shall be responsible for ensuring that these
3 funds, or so much thereof as may be necessary, are used
4 solely for the purpose specified in this act, and that
5 no obligations are incurred in excess of the sum
6 appropriated. The allottee of the funds appropriated
7 under section 2 of this act shall be the Governor of Yap
8 State or his designee; PROVIDED THAT, the allottee of
9 funds appropriated under subsection 2(a) of this act
10 shall be the President of COM-FSM; the allottee of funds
11 appropriated under subsections 2(c) and 2(d) of this act
12 shall be the President of the Federated States of
13 Micronesia or his designee. The allottee of funds
14 appropriated under sections 3 and 4 of this act shall be
15 the President of the Federated States of Micronesia or
16 his designee; PROVIDED THAT, the allottee of funds
17 appropriated under subsection 3(1) of this act shall be
18 the Governor of Kosrae State or his designee; the
19 allottee of funds appropriated under subsection 3(2) of
20 this act shall be the Mayor of Lelu Town Government or
21 his designee; the allottee of funds appropriated under
22 subsections 4(2) of this act shall be the Secretary of
23 the Department of Transportation, Communications and
24 Infrastructure, except that the allottee funds
25 appropriated under subsection 4(2)(f) shall be the

1 Pohnpei Port Authority (PPA); the allottee of funds
2 appropriated under subsections 4(3)(a), 4(3)(l) and
3 4(3)(m) of this act shall be the Pohnpei Transportation
4 Authority (PTA); the allottee of funds appropriated
5 under subsections 4(3)(b) and 4(3)(c) of this act shall
6 be the Luhkenmoanlap of Kitti; the allottee of funds
7 appropriated under subsections 4(3)(d), 4(3)(e),
8 4(3)(f), 4(3)(g) and 4(3)(o) of this act shall be the
9 Meninkeder of Madolenihmw; the allottee of funds
10 appropriated under subsections 4(3)(i) and 4(3)(j) of
11 this act shall be the Secretary of the Department of
12 Health and Social Affairs or his designee; the allottee
13 of funds appropriated under subsection 4(3)(h) of this
14 act shall be the Director of COM-FSM Land Grant Program
15 or his designee; the allottee of funds appropriated
16 under subsection 4(3)(n) of this act shall be the Vice
17 President of the Federated States of Micronesia or his
18 designee. The allottee of the funds appropriated under
19 subsections 5(1) and 5(6) of this act shall be the
20 Governor of Chuuk State or his designee; the allottee of
21 the funds appropriated under subsection 5(2) of this act
22 shall be the Mortlocks Island Development Authority
23 (MIDA); the allottee of funds appropriated under
24 subsection 5(3) of this act shall be the Mayor of Weno
25 Municipal Government or his designee; the allottee of

1 the funds appropriated under subsection 5(4) of this act
2 shall be the Southern Namoneas Development Authority;
3 the allottee of the funds appropriated under subsection
4 5(5) of this act shall be the Faichuk Development
5 Authority. The authority of the allottee to obligate
6 funds appropriated by this act shall lapse on September
7 30, 2022."

8 Section 3. This act shall become law upon approval by the
9 President of the Federated States of Micronesia or upon its
10 becoming law without such approval.
