

AN ACT

To further amend Public Law No. 20-141, as amended by Public Laws Nos. 20-145, 20-163, 20-164, 20-190 and 21-05, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other projects and programs in the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 20-141, as amended
2 by Public Laws Nos. 20-145, 20-163 and 20-164, is hereby further
3 amended to read as follows:

10 Section 2. Section 6 of Public Law No. 20-141, as amended
 11 by Public Laws Nos. 20-163, 20-190 and 21-05, is hereby further
 12 amended to read as follows:

13 "Section 6. Allotment and management of funds and
 14 lapse date. All funds appropriated by this act shall
 15 be allotted, managed, administered and accounted for in
 16 accordance with applicable laws, including, but not
 17 limited to, the Financial Management Act of 1979. The
 18 allottee shall be responsible for ensuring that these
 19 funds, or so much thereof as may be necessary, are used
 20 solely for the purpose specified in this act, and that
 21 no obligations are incurred in excess of the sum
 22 appropriated. The allottee of the funds appropriated
 23 under section 2 of this act shall be the Governor of
 24 Yap State or his designee. The allottee of the funds
 25 appropriated under sections 3 and 4 of this act shall

1 be the President of the Federated States of Micronesia
2 or his designee; PROVIDED THAT, the allottee of funds
3 appropriated under subsections 3(a), 3(b), 3(c), 3(e),
4 3(f), 3(g), 3(h), 3(j), 3(k), 3(l), 3(m), 3(n), 3(o),
5 3(p), 3(q), 3(s), 3(t), 3(u), 3(v), 3(w), 3(x), 3(y),
6 3(z) and 3(a3) to 3(a10) of this act shall be the Mayor
7 of Lelu Town Government or his designee; the allottee
8 of funds appropriated under subsections 3(d), 3(i),
9 3(r), 3(a2) and 3(a11) to 3(a25) of this act shall be
10 the Mayor of Tafunsak Municipal Government or his
11 designee; the allottee the allottee of funds
12 appropriated under subsections (a27), (a28) and (a29)
13 of this act shall be the Governor of Kosrae State or
14 his designee; the allottee of funds appropriated under
15 subsection 3(a26) is the Secretary of the FSM
16 Department of Education or his designee; the allottee
17 of funds appropriated under subsection 4(1)(v) of this
18 act shall be the Meninkeder lapalap of Madolenihmw
19 Municipal Government or his designee; the allottee of
20 funds appropriated under subsection 4(1)(w) of this act
21 shall be the Chief Minister of U Municipal Government
22 or his designee; the allottee of funds appropriated
23 under subsections 4(1)(x) and 4(4)(n) of this act shall
24 be the District Administrator of Nett Municipal
25 Government or his designee; the allottee of funds

1 appropriated under subsection 4(1)(y) of this act shall
2 be the Luhken Menlap of Kitti Municipal Government or
3 his designee; the allottee of funds appropriated under
4 subsection 4(1)(z) of this act shall be the Chief
5 Magistrate of Sokehs Municipal Government or his
6 designee; the allottee of funds appropriated under
7 subsections 4(2)(a) to 4(2)(s), 4(2)(ab) and 4(4)(a),
8 4(4)(b), 4(4)(c), 4(4)(d), 4(4)(g), 4(4)(h), 4(4)(i),
9 4(4)(j) and 4(4)(k) of this act shall be the Pohnpei
10 Transportation Authority (PTA); the allottee of funds
11 appropriated under subsection 4(3)(n) of this act shall
12 be the Secretary of the Department of Health and Social
13 Affairs or her designee, the allottee of funds
14 appropriated under subsections 4(2)(h), 4(2)(q),
15 4(2)(u), 4(2)(ac), 4(2)(v), 4(2)(w), 4(2)(x), and
16 4(2)(z) of this act shall be the Secretary of the
17 Department of Transportation, Communications and
18 Infrastructure or his designee; the allottee of funds
19 appropriated under subsection 4(2)(y) of this act shall
20 be the Pohnpei Port Authority; the allottee of funds
21 appropriated under subsection 4(2)(aa) of this act
22 shall be the Secretary of the Department of Resources
23 and Development or his designee; the allottee of fund
24 appropriated under subsections 4(1)(a2) and 4(4)(l) of
25 this act shall be the Mayor of Pingelap Municipal

1 Government; the allottee of funds appropriated under
 2 subsections 4(1)(a1) and 4(4)(m) of this act shall be
 3 the Chief Magistrate of Mwoakilloa Municipal
 4 Government; the allottee of funds appropriated under
 5 subsection 4(1)(a3) of this act shall be the Luhken
 6 Kolwof of Sapuwafik Municipal Government; the allottee
 7 of funds appropriated under subsection 4(1)(a4) of this
 8 act shall be the Mayor of Nukuoro Municipal Government;
 9 the allottee of funds appropriated under subsection
 10 4(1)(a5) of this act shall be the Chief Magistrate of
 11 Kapingamarangi Municipal Government; The allottee of
 12 funds appropriated 4(3)(a5) shall be the Secretary of
 13 the Department of Health and Social Affairs. The
 14 allottee of the funds appropriated sections 5 of this
 15 act shall be the Governor of Chuuk State or his
 16 designee; PROVIDED THAT, the allottee of funds
 17 appropriated under subsections 5(g) and 5(j) of this
 18 act shall be the FSM Telecommunication Corporation or
 19 its designee. The authority of the allottee to
 20 obligate funds appropriated by this act shall lapse on
 21 September 30, 2021."


