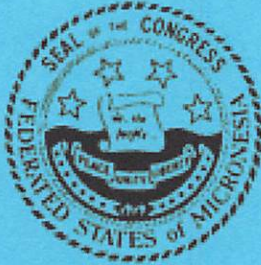

AN ACT

To further amend sections 1, 8, 9, and 12, of Public Law No. 21-185, as amended by Public Laws Nos. 21-210, 21-221, 21-238, 22-01, and 22-30 to appropriate \$335,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2021, to provide supplemental funding for Grants, Subsidies and Contributions, Capital and Human Resources Development, and to change the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1. Section 1 of Public Law No. 21-185, as
2 amended by Public Laws Nos. 21-210, 21-221, 21-238, and 22-01, is
3 hereby further amended to read as follows:

4 "Section 1. Purpose. The purpose of this act is to
5 appropriate the sum of \$75,222,351 from the General Fund
6 of the Federated States of Micronesia for the fiscal
7 year ending September 30, 2021, for the purpose of
8 funding the operations of all branches of the National
9 Government of the Federated States of Micronesia, its
10 agencies, various programs, grants, subsidies and
11 contributions and Capital and Human Resources
12 Development. The National Government's share of the
13 Amended Compact funds has been reduced to zero; EXCEPT
14 THAT; the National Government will retain the Compact
15 Sector Grant amount for COM-FSM and 10 percent of the
16 Supplemental Education Grant funds as is reflected in
17 the budget for the Department of Education. The sum

1 appropriated herein shall be apportioned as follows:"

2 Section 2. Section 8 of Public Law No. 21-185, as amended by
3 Public Laws Nos. 21-210, 21-221, 21-238, 22-01, and 22-30 is
4 hereby further amended to read as follows:

5 "Section 8. Grants, Subsidies and Contributions.

6 The sum of \$18,649,316, or so much thereof as may be
7 necessary, is hereby appropriated from the General Fund
8 of the Federated States of Micronesia for the fiscal
9 year ending September 30, 2021, for the following
10 grants, subsidies and contributions during the fiscal

23 Section 4. Section 12 of Public Law No. 21-185, as amended by
24 Public Laws Nos. 21-210, 21-221, 21-238, and 22-01 is hereby
25 further amended to read as follows:

1 "Section 12. Allotment and Management of Funds and
2 Lapse Dates.

3 (1) General provisions.

4 (a) All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in
6 accordance with applicable law, including, but not
7 limited to, the Financial Management Act of 1979.

8 (b) The allottees shall be responsible for
9 ensuring that these funds, or so much thereof as may be
10 necessary, are used solely for the purposes specified in
11 this act, and that no obligations are incurred in excess
12 of the sums appropriated.

13 (2) Allottees. The allottees of the funds
14 appropriated by this act are as follows:

15 (a) Section 2 - the allottee of these funds
16 shall be the President of the Federated States of
17 Micronesia;

18 (b) Section 3 - the allottee of these funds
19 shall be the Speaker of the Congress of the Federated
20 States of Micronesia;

21 (c) Section 4 - the allottee of these funds
22 shall be the Chief Justice of the Supreme Court of the
23 Federated States of Micronesia;

24 (d) Section 5 - the allottee of these funds
25 shall be the Public Auditor of the Federated States of

1 Micronesia;

2 (e) Sections 6 through 9 - the allottee of these
3 funds shall be the President of the Federated States of
4 Micronesia; PROVIDED, HOWEVER, that for the following
5 subsections of sections 8 through 9 of this act:

6 (i) Sections 8(1)(f) and 8(13)(g) - the
7 allottee of these funds shall be the Chair of the Joint
8 Committee on Compact Review and Planning;

9 (ii) Section 8(8)(a) - the allottee of these
10 funds shall be the Governor of the state of Kosrae;

11 (iii) Section 8(8)(b) - the allottee of these
12 funds shall be the Governor of the state of Pohnpei;

13 (iv) Section 8(8)(c) - the allottee of these
14 funds shall be the Governor of the state of Chuuk;

15 (v) Section 8(8)(d) - the allottee of these
16 funds shall be the Governor of the state of Yap;

17 (vi) Section 8(11) - the allottee of these
18 funds shall be the Public Auditor of the Federated
19 States of Micronesia;

20 (vii) Sections 8(12) and 9(11)(v) - the
21 allottee of these funds shall be the Speaker of the
22 Congress of the Federated States of Micronesia;

23 (viii) Section 8(13)(a) - the allottee of
24 these funds shall be the President of the College of
25 Micronesia-FSM;

1 (ix) Section 8(13)(d) through (g) - the
2 allottee of these funds shall be the Chief Justice of
3 the respective State Supreme Court;

4 (x) Section 8(13)(h) - the allottee of
5 these funds shall be the Chief Justice of the Supreme
6 Court of the Federated States of Micronesia;

7 (xi) Section 8(13)(t) - the allottee of
8 these funds shall be the National Olympic Committee;

9 (xii) Section 8(13)(u) - the allottee of
10 these funds shall be the Principal of Saint Cecilia
11 Catholic School;

12 (xiii) Section 9(1) - the allottee of these
13 funds shall be the President of the College of
14 Micronesia-FSM;

15 (xiv) Section 9(3)(b) - the allottee of these
16 funds shall be the Governor of the state of Kosrae;

17 (xv) Section 9(3)(c) - the allottee of these
18 funds shall be the Governor of the state of Pohnpei;

19 (xvi) Sections 9(3)(d) and 9(11)(w) - the
20 allottee of these funds shall be the Governor of the
21 state of Chuuk;

10 these funds shall be the Governor of the state of Chuuk;

11 (xxii) Section 9(11)(g) – the allottee of
12 these funds shall be the Secretary of the Department of
13 Transportation, Communications and Infrastructure;

14 (xxiii) Section 8(13)(r) the allottee of these
15 funds shall be the Governor of the State of Yap;

16 (xxiv) Section 9(3)(y) – the allottee of these
17 funds shall be the Governor of the state of Chuuk;

18 (xxv) Section 9(3)(z) – the allottee of these
19 funds shall be the Governor of the state of Pohnpei;

20 (xxvi) Section 9(3)(aa) – the allottee of
21 these funds shall be the Governor of the state of
22 Kosrae;

23 (xxvii) Section 9(3)(bb) – the allottee of
24 these funds shall be the Governor of the state of Yap;

25 (xxviii) Section 9(11)(p) and (s) – the allottee

1 of these funds shall be the Governor of the State of
2 Chuuk;

3 (xxix) Section 9(11)(q) – the allottee of these
4 funds shall be the Governor of the State of Yap;

5 (xxx) Section 9(11)(r) – the allottee of these
6 funds shall be the Governor of the State of Kosrae;

7 (xxxii) Section 9(3)(t) – the allottee of these
8 funds shall be the President of the FSM Association of
9 Chamber of Commerce; and

10 (xxxii) Section 9(4)(h) – the allottee of these
11 funds shall be the Governor of the State of Chuuk.”

12 Section 5. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its
14 becoming law without such approval.


