AN ACT

To further amend Public Law No. 20-155, as amended by Public Laws Nos. 20-177, 20-188, 21-61, 21-88, 21-119, 21-150 and 22-08, by amending sections 4 and 6 thereof, for the purpose of changing the use and lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 20-155, as amended by  
2 Public Laws Nos. 20-177, 20-188 and 21- 150, is hereby further  
3 amended to read as follows:

4 "Section 4. Of the \$1,400,000 appropriated under  
5 this act, \$400,000 shall be apportioned for public  
6 projects and social programs for the people of Pohnpei  
7 State.

13 Section 2. Section 6 of Public Law No. 20-155, as amended by  
 14 Public Laws Nos. 20-177, 20-188, 21-119 and 21-150, is hereby  
 15 further amended to read as follows:

16 "Section 6. Allotment and management of funds and lapse  
 17 date. All funds appropriated by this act shall be  
 18 allotted, managed, administered and accounted for in  
 19 accordance with applicable laws, including, but not  
 20 limited to, the Financial Management Act of 1979. The  
 21 allottee shall be responsible for ensuring that these  
 22 funds, or so much thereof as may be necessary, are used  
 23 solely for the purpose specified in this act, and that  
 24 no obligations are incurred in excess of the sum  
 25 appropriated. The allottee of the funds appropriated

1 under section 2 of this act shall be the Governor of Yap  
 2 State or his designee; PROVIDED THAT the allottee of  
 3 funds appropriated under subsection 2(c) of this act  
 4 shall be the Speaker of the Congress of the Federated  
 5 States of Micronesia or his designee. The allottee of  
 6 funds appropriated under section 3 of this act shall be  
 7 the Governor of Kosrae State or his designee. The  
 8 allottee of funds appropriated under section 4 of this  
 9 act shall be the President of the Federated States of  
 10 Micronesia or his designee; PROVIDED THAT the allottee  
 11 of funds appropriated under subsections 4(1)(c) of this  
 12 act shall be the Governor of Pohnpei State or his  
 13 designee; the allottee of funds appropriated under  
 14 subsections 4(2)(a), 4(2)(b) and 4(3)(h) of this act  
 15 shall be the Pohnpei Transportation Authority; the  
 16 allottee of funds appropriated under subsections  
 17 4(2)(c), 4(2)(d), 4(2)(e) and 4(2)(g) of this act shall  
 18 be the Secretary of the Department of Transportation,  
 19 Communications and Infrastructure or his designee; the  
 20 allottee of funds appropriated under subsections  
 21 4(3)(a), 4(3)(e) and 4(3)(f) of this act shall be the  
 22 Luhken Moanlap of Kitti; the allottee of funds  
 23 appropriated under subsection 4(3)(g) of this act shall  
 24 be the Secretary of the Department of Education or his  
 25 designee. The allottee of funds appropriated under

1 subsection 4(3)(d) of this act shall be the Secretary of  
2 the Department of Resources and Development or his  
3 designee. The allottee of the funds appropriated under  
4 subsections 5(1) and 5(6) of this act shall be the  
5 Governor of Chuuk State or his designee; the allottee of  
6 the funds appropriated under subsection 5(2) of this act  
7 shall be the Mortlocks Island Development Authority  
8 (MIDA); the allottee of funds appropriated under  
9 subsection 5(3) of this act shall be the Mayor of Weno  
10 Municipal Government or his designee; the allottee of  
11 the funds appropriated under subsection 5(4) of this act  
12 shall be the Southern Namoneas Development Authority;  
13 the allottee of the funds appropriated under subsection  
14 5(5) of this act shall be the Faichuk Development  
15 Authority. The authority of the allottee to obligate  
16 funds appropriated by this act shall lapse on September  
17 30, 2022.”

1 Section 3. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
