

AN ACT

To further amend Public Law No. 22-37, as amended by Public Laws Nos. 22-45, 22-76, 22-178, 23-16 and 23-26, by amending section 3 thereof, to change the use of funds previously appropriated therein for the purpose of funding public projects and social programs for the people of Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 22-37, as amended by
2 Public Laws Nos. 22-178 and 23-26, is hereby further amended to
3 read as follows:

4 Section 3. Of the \$2,800,000 appropriated under this
5 act, \$400,000 shall be apportioned for public projects
6 and social programs for the people of Kosrae State.


