A RESOLUTION

To approve and accept a grant in the amount of \$68,480 from the United Nations Population Fund, to provide funding for the FSM Family Planning Program, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Population Fund issued a Grant
2 Award on February 10, 2026, to the Government of the Federated
3 States of Micronesia (Annotated), as amended, providing funding in
4 the amount of \$68,480 for the purpose of providing support to the
5 FSM Family Planning Program; and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, provides
8 that for foreign financial assistance to be valid it must be
9 approved by Congress by resolution, and,

10 WHEREAS that the Government of the Federated States of
11 Micronesia expresses its sincere appreciation and gratitude to the
12 United Nations Population Fund for extending this grant; now,


1 BE IT FURTHER RESOLVED that certified copies of this
