A RESOLUTION

To confirm the nomination of Mr. Peter Garamfel to serve as a member representing the state of Yap on the Board of Directors of the National Oceanic Resource Management Authority (NORMA).

1           WHEREAS, pursuant to section 201(1) of title 24 of the  
2 Code of the Federated States of Micronesia (Annotated), the  
3 Federated States of Micronesia established a five-member Board  
4 of Directors for the National Oceanic Resource Management  
5 Authority; and

6           WHEREAS, pursuant to section 201(1)(b) of title 24 of the  
7 Code of the Federated State of Micronesia (Annotated), the  
8 President of the Federated States of Micronesia nominates one  
9 member from each state to serve on the Board of Directors of  
10 NORMA, in consultation with each state governor and with the  
11 advice and consent of Congress; and

12           WHEREAS, pursuant to section 201(1)(a) of title 24 of the  
13 Code of the Federated States of Micronesia, (Annotated), the  
14 President has nominated Mr. Peter Garamfel, a nominee  
15 recommended by the Governor of the state of Yap, to serve as  
16 the Yap State representative on the Board of Directors of  
17 NORMA; and

18           WHEREAS, Mr. Peter Garamfel has the experience and  
19 qualifications which make him a suitable candidate to continue  
20 to serve on the NORMA Board of Directors; and

1 WHEREAS, board members are appointed to serve a two-year  
2 term; now, therefore,

3 BE IT RESOLVED by the Twenty-Fourth Congress of the  
4 Federated States of Micronesia, Fourth Regular Session, 2026,  
5 that Congress hereby confirms the nomination of Mr. Peter  
6 Garamfel to serve as a member of the Board of Directors of the  
7 National Oceanic Resource Management Authority, representing  
8 Yap State; and

9 BE IT FURTHER RESOLVED that certified copies of this  
10 resolution be transmitted to the President of the Federated  
11 States of Micronesia, the Governor of each state of the Nation,  
12 and Mr. Peter Garamfel.
