A RESOLUTION

To approve and accept a grant in the amount of \$4,000,000 from the Asian Development Bank, to provide support to the Sustainable Transport and Connectivity Enhancement Project, including all the terms and conditions of the assistance.

1           WHEREAS, the Asian Development Bank issued a Grant Award on  
2 January 7, 2026, to the Government of the Federated States of  
3 Micronesia providing funding in the amount of \$4,000,000, for the  
4 purpose of providing support to the Sustainable Transport and  
5 Connectivity Enhancement Project; and

6           WHEREAS, section 210(2) of title 55 of the Code of the  
7 Federated States of Micronesia (Annotated), as amended, requires  
8 that for foreign financial assistance to be valid it must be  
9 approved by Congress by resolution; and

10           WHEREAS, the Government of the Federated States of Micronesia  
11 expresses its sincere appreciation and gratitude to the Asian  
12 Development Bank for extending this grant; now, therefore,

13           BE IT RESOLVED by the Twenty-Fourth Congress of the Federated  
14 States of Micronesia, Fourth Regular Session, 2026, that Congress  
15 hereby approves and accepts the \$4,000,000 grant for the Asian  
16 Development Bank, including all the terms and conditions thereof;
