A RESOLUTION

To approve and accept a grant in the amount of \$347,862 from the United States Department of Health and Human Services, Office of the Secretary, to provide funding for the Family Planning Services Program in the Federated States of Micronesia, including all the terms and conditions of the assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services, Office of the Secretary, issued a Grant Award on March
3 31, 2026, to the Government of the Federated States of Micronesia,
4 providing funding in the amount of \$347,862, for the purpose of
5 providing support to the Family Planning Services Program in the
6 Federated States of Micronesia; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, requires
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; now, therefore,

11 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
12 States of Micronesia, Fourth Regular Session, 2026, that Congress
13 hereby approves and accepts the \$347,862 grant from the United
14 States Department of Health and Human Services, Office of the
15 Secretary, including all the terms and conditions thereof; and
