A RESOLUTION

To approve and accept a grant in the amount of \$186,074 from the United States Department of Health and Human Services, Health Resources and Services Administration, to fund the Maternal and Child Health Services Program in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, on April 15, 2026, the United States Department of
2 Health and Human Services, Health Resources and Services
3 Administration, issued a Grant Award in the amount of \$186,074,
4 to fund the Maternal and Child Health Services in the Federated
5 States of Micronesia; and

6 WHEREAS, the purpose of the assistance is to improve the
7 health of women and their families in the FSM; and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended, requires
10 that for foreign financial assistance to be valid it must be
11 approved by Congress by resolution; now, therefore,

12 BE IT RESOLVED by the Twenty-Fourth Congress of the
13 Federated States of Micronesia, Fourth Regular Session, 2026,
14 that Congress hereby approves and accepts the \$186,074 grant
15 from the United States Department of Health and Human Services,
16 Health Resources and Services Administration, including all the
17 terms and conditions thereof; and
