A RESOLUTION

Authorizing the President to resubmit the nomination of Mr. Johnny M. Silbanuz to serve as the FSM Consul General in Guam, U.S.A.

1           WHEREAS, during the First Special Session of the Twenty-  
2 Fourth Congress, 2025, the President submitted the nomination of  
3 Mr. Johnny M. Silbanuz to serve as the FSM Consul General in Guam,  
4 U.S.A.; and

5           WHEREAS, the resolution approving the nomination has  
6 not been adopted by Congress; and

7           WHEREAS, under section 207 of title 2 of the Code of the  
8 Federated States of Micronesia (Annotated), as amended, the  
9 President shall not resubmit the nomination of any person to the  
10 Twenty-Fourth Congress for its action if the Twenty-Fourth  
11 Congress shall have previously rejected such nomination, unless  
12 the Twenty-Fourth Congress shall by resolution authorize such  
13 resubmission; now, therefore,

14           BE IT RESOLVED by the Twenty-Fourth Congress of the Federated  
15 States of Micronesia, Fourth Regular Session, 2026, that Congress  
16 hereby authorizes the President to resubmit the nomination of Mr.  
17 Johnny M. Silbanuz to serve as the FSM Consul General in Guam,  
18 U.S.A.; and
