AUTHORIZING THE PRESIDENT TO SUBMIT THE RECOMMENDED NATIONAL GOVERNMENT COMPACT BUDGET REQUEST FOR FISCAL YEAR 2027 TO THE UNITED STATES OF AMERICA UNDER ARTICLE V OF THE 2023 FISCAL PROCEDURES AGREEMENT.

A RESOLUTION

Authorizing the President to submit the Recommended National Government Compact Budget Request for fiscal year 2027 to the United States of America under Article V of the 2023 Fiscal Procedures Agreement.

1 WHEREAS, the Federated States of Micronesia and the United
2 States of America have entered into the Compact of Free
3 Association, as amended; and

4 WHEREAS, section 103(4)(d) of title 55 of the Code of the
5 Federated States of Micronesia (Annotated), as amended, requires
6 the President of the Federated States of Micronesia to submit to
7 Congress a Recommended National Government Compact Budget Request
8 for the ensuing fiscal year; and

9 WHEREAS, section 103(5)(a) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, permits
11 Congress, by resolution, to authorize the President to submit the
12 Recommended National Government Compact Budget Request to the
13 United States; and

14 WHEREAS, section 103(5)(b) of title 55 of the Code of the
15 Federated States of Micronesia (Annotated), as amended, permits
16 Congress, by resolution, to recommend changes to the Recommended
17 National Government Compact Budget Request in any respect
18 consistent with the Compact, as amended; and

19 WHEREAS, section 303(6) of title 55 of the Code of the

1 Federated States of Micronesia (Annotated), as amended, sets the
 2 National Government share of the Compact Budget Requests for
 3 fiscal year 2024 and thereafter, at ten percent (10%) of the
 4 Compact funds received pursuant to the 2023 Amended Compact, after
 5 funding is provided for the College of Micronesia-FSM; and

6 WHEREAS, the Recommended National Government Compact Budget
 7 Request submitted by the President to Congress for fiscal year
 8 2027 reflects the current law and requests Compact Education
 9 Sector Grant funding in the amount of \$8,452,516 (including
 10 \$5,018,539 for the College of Micronesia-FSM), Compact Health
 11 Sector Grant funding in the amount of \$1,097,006, Compact
 12 Environment Sector Grant funding in the amount of \$562,843,
 13 Compact Private Sector Development Grant funding in the amount of
 14 \$687,883, Compact Public Sector Capacity Building Grant funding in
 15 the amount of \$1,565,948, Compact Enhanced Reporting and
 16 Accountability Sector Grant funding in the amount of \$280,000,
 17 Compact Infrastructure Sector Grant (National Share) funding in
 18 the amount of \$3,500,000, Compact Infrastructure Sector Grant
 19 (State Shares) funding in the amount of \$31,500,000, Compact IMF
 20 Grant (National Share) funding in the amount of \$1,022,000, and
 21 Compact IMF Grant (State Shares) funding in the amount of
 22 \$9,198,000; and

23 WHEREAS, it is the intent of Congress to concur with the
 24 above Compact grant allocations provided in the Recommended
 25 National Government Compact Budget Request submitted by the

1 President to Congress for fiscal year 2027; now, therefore,
2 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
3 States of Micronesia, Fourth Regular Session, 2026, that pursuant
4 to section 103(5)(a) of title 55 of the Code of the Federated
5 States of Micronesia (Annotated), as amended, Congress hereby
6 authorizes the President to submit the National Government Compact
7 Budget Request for the fiscal year 2027, in conformity with the
8 terms of this resolution, to the United States of America under
9 Article V of the 2023 Fiscal Procedures Agreement; and

10 BE IT FURTHER RESOLVED, that certified copies of this
11 resolution be transmitted to the President of the Federated States
12 of Micronesia, the Secretary of the Department of Finance and
13 Administration, and the Secretary of the Department of Foreign
14 Affairs.
