APPROVING AND ACCEPTING A GRANT IN THE AMOUNT OF USD \$300,000 FROM THE GOVERNMENT OF JAPAN, TO FUND THE GOODS AND SERVICES PROGRAM FOR THE FSM, TO ASSIST THE FISHERIES DEVELOPMENT PROGRAM, INCLUDING ALL THE TERMS AND CONDITIONS OF THE ASSISTANCE.

A RESOLUTION

Approving and accepting a grant in the amount of USD \$300,000 from the Government of Japan, to fund the Goods and Services Program for the FSM, to assist the fisheries development program, including all the terms and conditions of the assistance.

1 WHEREAS, on September 17, 2025, the Government of Japan
2 extended to the Federated States of Micronesia a grant in the
3 amount of USD \$300,000 as evidenced by a Memorandum of
4 Understanding (MOU) to fund the Goods and Services Program of
5 the same date; and

6 WHEREAS, the grant was awarded to the Federated States of
7 Micronesia to assist the fisheries development program; and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended, requires
10 that the foreign financial assistance to be valid it must be
11 approved by Congress by resolution; now, therefore,

12 BE IT RESOLVED by the Twenty-Fourth Congress of the
13 Federated States of Micronesia, Fourth Regular Session, 2026,
14 that Congress hereby approves and accepts the USD 300,000
15 grant from the Government of Japan to fund the Goods and
16 Services Program for the FSM, and to restrict the use of the
17 grant to its intended as provided in Article 2 of the MOU; and

18 BE IT FURTHER RESOLVED that the Government of the Federated
19 States of Micronesia wishes to express its appreciation and

1 gratitude to the Government of Japan for extending this grant;
2 and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated
5 States of Micronesia, the Secretary of the Department of
6 Justice, and the Secretary of the Department of Foreign Affairs.


