
A BILL FOR AN ACT

To further amend Public Law No. 19-10, as amended by Public Laws Nos. 19-26, 19-42, 19-51, 19-56, 19-72, 19-78, 19-96, 19-132, 19-163, 20-03, 20-25, 20-58, 20-76, 20-116, 21-29, 21-64, 21-196, 22-10, 22-133, 23-84, 23-163, 24-12, and 24-52, by amending section 6 thereof, to extend the lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2 Section 1. Section 6 of Public Law No. 19-10, as amended by
3 Public Laws Nos. 19-26, 19-42, 19-72, 19-96, 20-25, 20-116, 21-29,
4 21-64, 21-196, 22-10, 22-133, 23-84, 23-163, 24-12, and 24-52, is
5 hereby further amended to read as follows:

6 "Section 6. Allotment and management of funds and lapse
7 date. All funds appropriated by this act shall be
8 allotted, managed, administered and accounted for in
9 accordance with applicable laws, including, but not
10 limited to, the Financial Management Act of 1979. The
11 allottee shall be responsible for ensuring that these
12 funds, or so much thereof as may be necessary, are used
13 solely for the purpose specified in this act, and that
14 no obligations are incurred in excess of the sum
15 appropriated. The allottee of the funds appropriated
16 under section 2 of this act shall be the Governor of Yap
17 State; PROVIDED THAT, the allottee of funds appropriated

1 under subsection 2(h) of this act shall be the President
2 of COM-FSM. The allottee of funds appropriated under
3 sections 3 and 4 of this act shall be the President of
4 the Federated States of Micronesia or his designee;
5 PROVIDED THAT, the allottee of funds appropriated under
6 subsections 3(a), (b), (c), (d), (e), (f), (g), (h),
7 (i), (j) and (k) of this act shall be the Mayor of Lelu
8 Town Government; the allottee of funds appropriated
9 under section 3(1) of this act shall be the Mayor of
10 Malem Municipal Government or his designee; the allottee
11 of funds appropriated under subsection 3(y) of this act
12 shall be the Mayor of Tafunsak Municipal Government or
13 his designee; the allottee of funds appropriated under
14 3(ab) of this act shall be the Governor of Kosrae or his
15 designee; the allottee of funds appropriated under
16 subsections 4(1)(a), 4(1)(b), 4(2)(g), 4(2)(h) and
17 4(3)(o) of this act shall be the Secretary of the
18 Department of Transportation, Communications and
19 Infrastructure; the allottee of funds appropriated under
20 subsections 4(2)(i), 4(3)(a), 4(3)(b) and 4(3)(d) of
21 this act shall be the Pohnpei Transportation Authority;
22 and the allottee of funds appropriated under subsections
23 4(3)(f) and 4(3)(h) of this act shall be the Pohnpei
24 Utility Corporation. The allottee of funds appropriated
25 under subsections 5(1), 5(3) and 5(6) of this act shall

1 be the Governor of Chuuk State or his designee. The
2 allottee of funds appropriated under subsection 5(2) of
3 this act shall be the Mortlock Islands Development
4 Authority. The allottee of funds appropriated under
5 subsection 5(4) of this act shall be the Southern
6 Namoneas Development Authority. The allottee of funds
7 appropriated under subsection 5(5) of this act shall be
8 the Faichuk Development Authority. The authority of the
9 allottee to obligate funds appropriated by this act
10 shall lapse on September 30, [~~2026~~] 2028."

11 Section 2. This act shall become law upon approval by the
12 President of the Federated States of Micronesia or upon its becoming
13 law without such approval.
