
A BILL FOR AN ACT

To further amend Public Law No. 21-43, as amended by Public Laws Nos. 21-54, 21-71, 21-82, 21-103, 21-107, 21-158, 21-186, 21-235, 22-16, 22-50, 22-68, 22-123, 22-149, 22-192, 23-89, and 24-02, by amending section 6 thereof, to extend the lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-43, as amended
2 by Public Laws Nos. 21-54, 21-71, 21-107, 21-158, 21-235, 22-123,
3 23-89, and 24-02, is hereby further amended to read as follows:
4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that no
12 obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee; PROVIDED THAT, the allottee of
16 funds appropriated under subsection 2(f) of this act shall

1 be the President of the COM-FSM Institute. The allottee
2 of funds appropriated under sections 3 and 4 of this act
3 shall be the President of the Federated States of
4 Micronesia or his designee; PROVIDED THAT, the allottee of
5 funds appropriated under subsection 3(1) of this act shall
6 be the Governor of Kosrae State or his designee; the
7 allottee of funds appropriated under subsection 3(2) of
8 this act shall be the Mayor of Lelu Town Government or his
9 designee. The allottee of funds appropriated under
10 section 4(1) and 4(3)(1) of this act shall be the Vice
11 President; The allottee of funds appropriated under
12 subsection 4(1)(a) of this act shall be the Secretary of
13 the Department of Transportation, Communications and
14 Infrastructure or his designee, except that the allottee
15 of funds appropriated under subsections 4(2)(e), 4(3)(o),
16 4(4)(j), 4(4)(k), 4(4)(l) and 4(4)(m) of this act shall be
17 the Pohnpei Transportation Authority (PTA); the allottee
18 of funds appropriated under subsections 4(2)(l), 4(3)(d)
19 and 4(3)(f) of this act shall be the Secretary of the
20 Department of Education or his designee; the allottee of
21 funds appropriated under subsection 4(2)(h) of this act
22 shall be the President of COM-FSM; the allottee of funds
23 appropriated under subsection 4(2)(m) of this act shall be
24 the Mayor of Nukuoro Municipal Government or his designee;
25 the allottee of funds appropriated under subsection

1 4(2) (j) of this act shall be the Secretary of the FSM
2 Department of Resources and Development; the allottee of
3 funds appropriated under subsections 4(3) (a), 4(3) (b),
4 4(3) (e), 4(3) (h), 4(3) (i) and 4(3) (k) of this act shall be
5 the Meninkeder of Madolenihmw; the allottee of funds
6 appropriated under subsection 4(3) (c) of this act shall be
7 the Chief Justice of Madolenihmw Municipal Government; the
8 allottee of funds appropriated under subsection 4(3) (g) of
9 this act shall be the Luhkenmoanlap of Kitti; the allottee
10 of funds appropriated under subsection 4(3) (j) of this act
11 shall be the Speaker of Isokonedi of Kitti; the allottee
12 of funds appropriated under subsection 4(3) (m) of this act
13 shall be the Director of Pohnpei Public Safety. The
14 allottee of the funds appropriated under sections 5(1) and
15 5(6) of this act shall be the Governor of Chuuk State or
16 his designee; the allottee of the funds appropriated under
17 subsection 5(2) of this act shall be the Mortlocks Island
18 Development Authority (MIDA); the allottee of the funds
19 appropriated under subsection 5(4) of this act shall be
20 the Southern Namoneas Development Authority; the allottee
21 of the funds appropriated under subsection 5(5) of this
22 act shall be the Faichuk Development Authority. The
23 allottee of funds appropriated under subsection 5(3) of
24 this act shall be the Mayor of Weno Municipal Government
25 or his designee. The authority of the allottee to
