

A BILL FOR AN ACT

To further amend Public Law No. 19-152, as amended by Public Laws Nos. 19-162, 20-08, 20-27, 20-118, 21-23, 21-60, 21-97, 21-118, 22-112, 23-37, 23-94, and 24-13, by amending section 6 thereof, to extend the lapse date of certain funds previously appropriated therein, for the purpose of funding public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 19-152, as amended
2 by Public Laws Nos. 19-162, 20-08, 20-118, 21-23, 21-118,
3 22-112, 23-37, 23-94, and 24-13, is hereby further amended to
4 read as follows:

5 "Section 6. Allotment and management of funds and
6 lapse date. All funds appropriated by this act shall
7 be allotted, managed, administered and accounted for
8 in accordance with applicable laws, including, but
9 not limited to, the Financial Management Act of 1979.
10 The allottee shall be responsible for ensuring that
11 these funds, or so much thereof as may be necessary,
12 are used solely for the purpose specified in this
13 act, and that no obligations are incurred in excess
14 of the sum appropriated. The allottee of the funds
15 appropriated under section 2 of this act shall be the
16 Governor of Yap State or his designee. The allottee
17 of funds appropriated under sections 3 and 4 of this

1 act shall be the President of the Federated States of
2 Micronesia or his designee, PROVIDED THAT the
3 allottee of funds appropriated under subsections
4 3(a), 3(b), 3(c), and 3(e) of this act shall be the
5 Mayor of Utwe Municipal Government or his designee;
6 the allottee of funds appropriated under subsections
7 3(f) and 3(g) of this act shall be the Mayor of
8 Tafunsak Municipal Government or his designee; the
9 allottee of funds appropriated under section 3(1)(d)
10 of this act shall be the Mayor of Malem Municipal
11 Government or his designee; the allottee of funds
12 appropriated under subsection 4(1)(b) of this act
13 shall be the Pohnpei Transportation Authority (PTA);
14 the allottee of funds appropriated under subsections
15 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d) and 4(3)(d) of
16 this act the Secretary of the Department of
17 Transportation, Communications and Infrastructure or
18 his designee. The allottee of funds appropriated
19 under subsections 5(1), 5(4)(a) and 5(6) of this act
20 shall be the Governor of Chuuk State or his designee.
21 The allottee of funds appropriated under subsection
22 5(2) of this act shall be the Mortlock Islands
23 Development Authority. The allottee of funds
24 appropriated under subsection 5(3) of this act shall
25 be the Mayor of Weno Municipal Government or his
